

**ADOPTED PARISH COUNCIL ACTION PLAN FROM THE THREE VILLAGE PLANS
(CLEE HILL, KNOWBURY AND CAYNHAM)**

Personal information/Employment/Personal Safety/Services

- *To pursue the provision of additional Police presence in the Parish area and to support the establishment of a Neighbourhood Watch Schemes.*

Affordable Housing

- *To ensure restricted development, encourage limited small-scale development of affordable housing for local people where there is a proven need.*

Transport and Road Safety

- *Pursue the enforcement of the 30mph speed restriction through the village of Clee Hill, to ask the County Council to review parking restrictions and the provision of a pelican crossing.*
- *Pursue the provision of an appropriate speed limit through the villages of Knowbury and Caynham with appropriate traffic calming measures and a restriction on heavy vehicles using Caynham Road.*
- *To ensure that the Highways Authority maintain the roads to a satisfactory standard and to ensure adequate drainage preventing the problem of Surface Water.*
- *The review with the Highway Authority the winter gritting programme and the provision of salt bins.*
- *Pursue the provision of a lay-by opposite the church and a pavement running from the Village Hall to the Church.*

Footpaths/Bridleways

- *To consider the production of a brochure giving details of all footpaths and bridleways in the Parish area and to review the need to re-route or seek reinstatement of footbridges. To ensure the continual review of the conditions of the footpaths and bridleways and report any items that need repair to the County Council Footpaths Officer.*

Village Hall/Recreational Hall

- *The Parish Council to provide financial support to the village halls and to encourage their continued use with support to the Village Hall Committees in the activities they provide.*
- *The Parish Council to provide financial support to the recreational hall and to encourage its continued use with support to the Recreational Hall Committee in the facilities it provides both in respect of the hall and recreational field.*

Environment

- *The Parish Council to protect and preserve the environmental features of Caynham Parish.*
- *To monitor the amount of litter and dog mess in the village and where a problem persists seek advice from the District Councils Environmental Department on courses of action available.*
- *That the Parish Council give further consideration to the resurfacing of the car park area in Clee Hill.*
- *Work with the District Council in the introduction of the new refuse collection facilities, to pursue additional waste site facilities in Ludlow including weekend opening hours and to encourage residents to actively partake in the Recycling initiatives.)*
- *Consider the provision of additional streetlights in Caynham village and additional car parking.*

The Parish Council

- *Ensure that residents are kept informed of local issues by better publicity by use of the Parish Council Notice Board, publication of Minutes in appropriate Newsletters, the holding of Public Meetings and the provision of a Newsletter on important issues that will affect the community.)*

Young People

- *The Parish Council should always be mindful of the views and needs of young people when considering local issues on which it comments or makes decisions.*
