Securities means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000, Section 8, and other securities of any description, other than money deposited with a building society.

I understand that failure (without reasonable excuse);

- (b) to participate in any discussion or vote in any matter considered at a meeting where I have a disclosable pecuniary interest in the matter in contravention of Section 31(4) of the Localism Act; or
- (c) when acting as a single Executive Member to take any steps other than for the purpose of enabling the matter to be dealt with by myself, in contravention of Section 31(8) of the Localism Act; or
- (d) knowingly or recklessly to provide information under Section 30(1), 31(2), 31(3) or 31(7) of the Localism Act which is false or misleading;

is a criminal offence under Section 34 of the Localism Act, punishable by a fine not exceeding level 5 on the standard scale (currently  $\pounds$ 5,000), and disqualification as a Member or Coopted Member of Winchfield Parish Council or any other relevant authority for a period not exceeding five years.

I also understand that I must, within 28 days of becoming aware of any new interests, provide written notification to the Clerk.
