Minutes of the Meeting held on Thursday, 4 June 2026 at 8pm at Ulcombe Village Hall.

There were 12 residents present.

ADDRESS: Mansion Farm Knowle Hill Ulcombe Kent ME17 1ES. It was RESOLVED to approve this application.

APPLICATION REF: 26/500904/FULLPROPOSAL: Conversion of existing porch into store and relocation of front door. ADDRESS: 1 Water Lane Cottages Water Lane Harrietsham Kent ME17 1DL. **APPROVED**

APPLICATION REF: 26/501073/PNQCLAPROPOSAL: Prior notification for the change of use of a building and any land within its curtilage from agricultural to 2no. dwellinghouses and associated operation development. For its prior approval to:

- Transport and Highways impacts of the development.
- Noise impacts of the development.
- Contamination risks on the site.
- Flooding risks on the site.

Whether the location or siting of the building makes it otherwise impractical or undesirable for the use of the building to change from agricultural use to C3 (dwellinghouses). Design and external appearance impacts on the building. Provision of adequate natural light in all habitable rooms of the dwellinghouses. ADDRESS: Homesby Court, Windmill Hill, Ulcombe, Kent ME17 1EP. **APPROVED**

(b) It was RESOLVED to purchase two further No Dog Signs. It was also agreed to investigate updating the information signage at the main entrance.

(c) A draft lease agreement for Big Bear Football Club's use of the recreation ground was reviewed. It was RESOLVED that the level of use required was excessive and would have a detrimental impact on residents and users of the village hall. It was agreed that further discussions should take place.

It was RESOLVED to update the Kent Highways Improvement Plan to include further works at Wents Crossroads and Pye Corner.

10. South East Water

It was RESOLVED that once Ulcombe Water Watch had collated their resident's impact report, then the Council would review and support its submission to Katie Lam MP.
