1 Respective responsibilities of the auditor and the authority

The smaller authority has reported a negative value for its general reserve, as it is awaiting a substantial VAT reclaim at the year end. In future, the smaller authority should be mindful of earmarking funds that have not yet been received.

The AGAR was not accurately completed before submission for review. The AGAR has been amended.
