P/HOU/2025/07399 - Limbury Weymouth Road Martinstown - Installation of a new dormer window on northwest elevation. Install double doors and create terrace to northwest elevation

P/FUL/2025/01469 - Steepleton Manor Residential Home B3159 Junction A35T To Rew Manor Winterbourne Steepleton DT2 9LG - Erect new extension in the walled garden of the existing main building at Steepleton Manor, to comprise 7 x 1-bedroom 2-person apartments (Use Class C3) with bin enclosure and new link building to connect with the main building (Amended plans/information).

P/FUL/2025/07124 - Grove Hill Dairy, Grove Hill Martinstown DT2 9JP - Erect new agricultural dwelling and garage
