### 5 Planning

Information received regarding a new sheep house at Valley Farm, Stainmore. Holme Dyke 2 Railway Cottages Bowes, T1 Ash – fell in conservation area – no observations The Ancient Unicorn – Formation of 3 dwellings and hotel accommodation with associated landscaping – clerk to reply as follows:-

The tree report (2327207) seems to refer to a tree which is not within the planning application area. Are we to assume that the intention is to remove this tree as well as the tree within the marked area (2327208). Please note that the first tree (2327207) is not shown on the application plan. Both tree reports were move than 5 years old. We were unable to find a proposed site plan amongst the documentation provided.

The archway, which is to be retained as it is listed, seems inadequate for emergency and refuse vehicles as we responded to a previous application.

### 6. Correspondence

Information letter on Scam Mail approved for the notice board

We have received a reply from Lynn Todhunter, secretary of Bowes Lights, with the following responses: -

- What is the total amount you need to raise for phase 1 we are looking for £7,900.00. This is to include the cost of insurance. additional electrical work at the village hall and the expenditure related to our Bowes Lights Lottery Draw.
- What have you raised so far £4,325.00 with an anticipated £450.00 further fundraising within the village, and an expectation of grants in the region of £3,200.00. However, the grant funding cannot be spent in 2018 until it becomes an actual rather than an expectation. Even without the possible grant money, we will be spending £2,700.00 on lighting this year (with the promised funds this would increase to £5,900.00.
- What are your arrangements for powering the lights. The lights will be strung in sequences, each sequence requiring a single power point. These points will be provided by the village hall, and donor houses though out the street.

The idea is good but the thought of using mains electricity in and across public spaces is a cause for concern amongst the councillors. Would a representative from the Bowes Lights Group be able to make a presentation to the councillors on how this years work is progressing and how they intend to develop this going forward. The council can only commit funding in the current financial year, and you have enough funding already to complete phase 1. Funding for future projects will have to be applied for at the time it will be spent.
