Minutes of a Planning Committee Meeting held at 7.30pm on Monday 16th January 2023 in the Council Offices, Langton Green Recreation Ground

MEMBERS OF THE PUBLIC PRESENT: There were no members of the public present.

1. To enquire if anyone intends to record the meeting

The Assistant Clerk advised that she was recording the meeting on a laptop for the purpose of accuracy of the minutes and would delete the recording once the minutes had been signed at the next Planning Committee meeting.

2. To receive and approve apologies and reasons for absence

Apologies were received from Cllr Curry who had a prior engagement and Cllrs Tarricone and Rajah who were both unwell.

3. **Disclosures of Interests**

The Assistant Clerk declared an interest in application no. 22/03541/FULL – she is the applicant.

5. **Minutes: RESOLVED** That the minutes of the Planning Committee meeting held on 14th November 2022 be approved as a correct record of the meeting and signed by the Chairman.

6. Public Open Session:

There were no members of the public present.

7. Planning Appeals

- 21/02615/LAWPRO Millford House, Penshurst Road, Speldhurst: There was nothing to report.
- 21/04144/FULL Land Adj Pax Cottage, Stockland Green Road, Speldhurst: There was nothing to report.

8. Terms of Reference

Councillors considered appending a list of Non-Material Considerations to the Terms of Reference on the request of the Environment Committee. It was agreed not to append the list for the following reasons:

- The parish council is merely a consultee and such a high level of detail was not required;
- Members of the committee are not technical planning experts and offer only a local opinion on behalf of the parish to assist the planning officer who makes the decision;
- By appending a list, the committee were opening themselves up to being challenged as to whether they had actually considered every item on the list and to prove that they had;
- Councillors were also concerned that apart from having to address every point on all
 applications, such a long list becomes exclusive and by implication prevents the
 consideration of an aspect not on the list.
- These factors made it unfeasible.

It was agreed that Cllr Norton would circulate a draft paragraph clarifying the situation for approval by members which could be incorporated into the Terms of Reference.

to element and alterations to the exterior design.

22/03438/FULL – 12 Hither Chantlers, Langton Green

Proposal: Demolition of existing garage and single storey side extension. Removal of main house hipped roof with associated alterations to first floor fenestration, Removal of part pitched roof to existing rear single storey extension and replace with flat roof and rooflights, Alterations to raise roof eaves to create second floor rooms, Erection of two-storey link and bedroom extension, Erection of front and rear dormers, Erection of new porch to front elevation.
