3 TO RECEIVE A REPORT FROM SQN LDR GEARY - RAF LAKENHEATH

Sqn Ldr Geary could not attend the meeting due to other commitments. He did however email the following report:-

In addition to the routine training sorties conducted throughout December 2022, 48th Fighter Wing deployed aircraft to Poland for deterrence operations on NATO's Eastern Flank.

48th Fighter Wing hosted a VIP visit by the Chief of Staff of the US Air Force at the end of last month. Councillors from Lakenheath and Feltwell attended the Tree Lighting ceremony and Winter Reception at RAF Lakenheath on 2nd December. During the event, the Councillors enjoyed some entertainment and refreshments and also had the opportunity to engage directly with the 48th Fighter Wing Commander, the Vice Commander, the Chief Master Sergeant, the Operations Group Commander and the RAF Commander.

The agreement for 48th Fighter Wing to use a small parcel of land outside of Gate 2 (Lords Walk) for parcel/shopping goods, deliveries and collections has been signed by the Defence Infrastructure Organisation and Elveden Estates. It is hoped that the land will be formally handed over to 48th Fighter Wing later this month.

48th Fighter Wing has been shortlisted for the Commander in Chief Installation Excellence Award for 2021/22. The Award Evaluation Team are visiting RAF Lakenheath this week to conduct their review/inspection.

Finally, please note that 48th Fighter Wing lost a lot of training sorties throughout November and December 2022 due to poor weather in the early mornings. Consequently, to try and avoid the bad weather, they are planning to start flying later in the day and continue flying later into the evening throughout January 2023.

A member of the public voiced their opinion stating that it was not a wise move to reduce the new cemetery budget by £5,000 as that would mean the Council having to borrow more money later with more cost to the town. They also suggested that because of new Councillors joining in May a meeting before the January precept meeting would be a good idea to explain the individual items.

Lastly, they asked in relation to grants paid out by the Council if something came to light could the Council go to the group to ask questions. The Clerk clarified that it would be followed up. A member of the Brandon Remembrance Playing Fields outlined facts for the Council to consider before making decisions on the second half of their payment and for the precept for 2023. Cllr Lukaniuk reported about the poor phlebotomy service at the Forest Surgery in Brandon. He is in communication with the head of West Suffolk Primary who is liaising with various providers to fill

Cllr Palmer stated he had been working on the phlebotomy matter for the last nine months and he has a meeting on 20th January with the head of Suffolk and Essex Phlebotomy Service and West Suffolk Council to help resolve the problem.

Cllr Wittam stated that the District Councillors no longer receive data from the Traffic Enforcement Officers, so it is hard to judge the efficacy of their services. He further commented he is still battling over the streetlight's anomalies.

Cllr Annear asked Cllr Palmer who has been dealing with the street lighting issues if he had any further comments he would like to make. Cllr Palmer replied he had been working on the issue for eighteen months. Cllr Lukaniuk stated at the last meeting at West Suffolk Council they had not budgeted to deal with the imbalance. He feels the disparity will still be with us in twelve months time.
