#### 2) Captain's Report:

April 3 : Friendly v Hamstreet . 3 teams of 3 players. Combined score loss 18 -51

**May 7**: Village Coronation celebrations : Treasure Hunt stall raised £84. After deductions of £16 for expenses, £26 was distributed as prize money and £42 as donations to 3 charities.

Aug 6 : London Beach cream tea. Profit for Club funds after expenses = approx. £400

Oct 16 : Friendly v Coxheath. 2 teams of 4 players. 1 match won (17-15) 1 match lost (4 -18)

- **Dec 17** : London Beach lunch. 35 attendees (8 from High Halden Bowls). Cheque for £1400 presented.
- **Feb 16** : Friendly v Headcorn cancelled. Illness and lack of players.

# 3) Treasurer's Report [2023/24 accounts]: From last year, subs raised from £2.50 to £3 per

session. Thanks to Joy and Janet for arranging two functions at London Beach, raising just over

£1000. Bank balance healthy enough to upgrade equipment (ie new mat, jacks and measures).

# 4) Secretary's report:

# Hall hire rate increase :

From 1 April 2024, Hall fees will increase from £31 to £40.50 per session. As a comparison, if the number of sessions from April are the same as last year, the Club will pay an additional £600 in Hall fees. There is an option to reduce this rate to £36 per session by paying for all sessions in advance to December 2024.

There was lengthy discussion among members on whether this option should be considered. Main advantage = saving of approx. £160 for this current year until December. Main disadvantage = uncertainty over Charter Hall's financial situation. Club funds would need to be monitored carefully with an option to increase weekly session fees if attendance and therefore income drops.

- (a) Members proposals: None received
- (b) Committee proposals : Questionnaire to be sent out later in the year including, for example:

Playing friendly matches v other clubs, playing competitions in-house, playing in S.E.K.

Summer/Winter leagues, trips to Potters/Warners, Summer/ Christmas socials etc.

(c) Reminder re. 2024 membership : Renewal due by 31st March 2024 (form completed

and subscription paid). MN to forward cash payments to the Treasurer.

# (d) Membership and waiting list:

joining. One has not replied, one of the other two is unwell but will contact in future.

# (e) League results :

2023 Spring Fours : Came top in round robin, lost to St. Michael's in semi-final

2023 summer pairs league : came 4<sup>th</sup> out of 6. Winners = Hothfield

2023 winter triples league : Tied for 1<sup>st</sup> place on points but had to settle for runners-up to Hamstreet on shot difference.
