139.15 **Apologies for Absence** – Apologies were received from Denis Shaughnessy (work pressures) and Ian Davies; County Councillor Edward Heron.

140.15 Disclosures of interest.

No disclosures of interests received.

141.15 **Minutes**

The council resolved the minutes were a true record of the meeting held on 27th October 2015.

142.15 Reports to be received.

District Cllr Diane Andrews.

Having just attended a meeting of Community First in Ringwood, Cllr Andrews highlighted the effects the government cuts were having on organisations such as Community First — they were also questioning whether they were successfully reaching the people that needed their services the most — in particular Night Stop.

Bob Jackson as the new Chief Executive of NFDC was working to maximise the capacity and effectiveness of the Council.

Finally her most recent task and finish projects included coastal erosion, child poverty and continuing development for councillors.

Councillors' reports:

Jenny Watts – Bramshaw Trust representative – defibrillator will be installed before the end of the month – the council resolved that the cabinet should be kept unlocked. Estimates for the proposed kitchen refurbishment would be presented to the Trustees at their next meeting, but the trust now needs to start fund raising.

Kay Harrison reported that a pony fell in broken manhole opposite the Bentley Garage – clerk to chase up HCC over getting it replaced.

David Johnston advised that the he had sent a draft of the amended standing orders to the clerk, and that he was working on the other procedures. He also confirm that the staging date for 'Auto Enrolment' for Bramshaw Parish Council was 1st April 2017.

Sue Bennison had advised the Forestry Commission of ditch clearing required along Bramble Hill Road. Also having successfully got one car removed from being parked on verge near Butcher's Corner, another one has appeared!

143.15 Public Participation Session

Mr and Mrs Bond from Penn Common expressed their concern over speeding traffic along Penn Common Road. Sue Bennison explained how the council was working with the Hampshire County Council and the police to try and find some method of physical traffic calming and that Cllr Edward Heron should be attending the next meeting with results of their recent consultation on the problem. The council also took on board that speeding traffic is not limited to the main routes through the parish but also occurred on other roads. The clerk has been touch with the verderers over this matter to see whether the speed van might attend, and currently this was been followed up by Sue Westwood – clerk of the verderers.
