KB/25/079 Approve Minutes of Meeting of 15th September 2025

a. To approve and sign the minutes of 15th September 2025

The minutes were agreed as a true record of the meeting and were signed by the Chair.

  - A KBRA member had kindly changed the names of the Kings Barton playgrounds on Google maps.
  - The 2a MUGA had been vandalised. The Clerk had contacted CALA who had undertaken repairs but would not install a CCTV camera.
- c. To deal with any correspondence
  - KBRA's AGM was due to be held on 12<sup>th</sup> November.



 A resident had complained about parking on Binstead Rd. He was liaising with CALA about the matter. It was acknowledged there was little KBC could do since the roads were not yet adopted.

# KB/25/080 <u>City and County Cllrs – matters that need to be brought to the Committee's attention</u>

- Cllr Porter's report had been circulated before the meeting. She said the final designs for the Andover Rd/ Welhouse Lane junct TRO (KB/25/065) including speed restrictions, parking, access across the swales and road closures, were being decided. She said it was likely to go to consultation in the following week. She said the new Barton Line cycle lane was being checked to ensure it was suitable for 8 year olds and commuters.
- ii Cllr Cramoysan said that Kings Barton Forum would be taking place 3<sup>rd</sup> November. He said that the CALA implementation plan for the highways contained reasonable detail. He said the CGR would encourage all residents to respond and that organisations could respond in a less structured way. He said the guestions would be written in an unbiased way.

#### KB/25/082 CALA – Matters regarding:

a. Update report from the meeting between KBC Chair, the Clerk and CALA (for items not on the agenda)

The Clerks report of the meeting had been circulated before the meeting. Cllr Watters said he had re-iterated that the lack of amenities was difficult for residents. Cllr Cramoysan confirmed that CALA had a letter from WCC regarding the new MUGA but the letter did not specify the size required. He said he felt that it would be fair to say that it should be full size because the original provision was for teenage use. He said he believed that a promise had been extracted from CALA to deliver a larger MUGA.

#### c. New streetlights in Winchester Avenue

A CALA employee had said that the lights were shielded (KB/25/067b) and there was nothing further that could be done, but, residents were saying the lights were too bright. Photos circulated could not confirm if the shielding was installed. Cllr Watters had brought the matter up in the meeting with CALA (KB/25/082a) and CALA had agreed to investigate. Cllr Watters pointed out the lights installation for the inside of Winchester Ave was not according to plan. This matter was included in the report to the KB Forum (KB/25/082b).

#### d. Landscaping on Centinel Rd

Residents in Centinel Rd had raised concerns that CALA was not landscaping their road to plan. The original plans were shared but Ms Barber said there was evidence that CALA was cutting corners. The Clerk had referred the matter to Ms Beard and WCC landscape dept.

#### a. Agree new play equipment and installation

#### a. Update on the planning process

CALA had now confirmed the building would not be available until the late Autumn of 2026. CALA confirmed they would be installing solar panels. Cllr Watters had asked that the flooring should be non-vinyl floors. The planning permission provided a considerable level of detail.

# b. Update on CIO progress and appointment of trustees

Cllr Turner confirmed that he now had 7 potential trustees who had agreed to put themselves forward. He said that he would be researching a form for the trustees to complete. Cllr Watters said that the volunteer DBS checks could be a self-declaration at this stage.

#### KB/25/086 Kings Barton Bus

The bus passenger data had been circulated before the meeting. Cllr De Stefano said that although the numbers were low they were not as bad as had been suggested. He pointed out that since the service was launched there has been an increase in the number of residents but the bus numbers had a downward trend. He said that adjustments to the service to include a route using Winchester Avenue would be very helpful. Cllr Porter explained that HCC was concerned that the road closures on Winchester Avenue would not allow for a 32 day notice of change of route until after the road closures had been completed. She noted that HCC was open to the idea of dropping the route to the station at peak times.
