

## KEMBERTON PARISH COUNCIL

Minutes of the meeting of Kemberton Parish Council  
held on Wednesday 8<sup>th</sup> March 2023 at Kemberton Village Hall

### **22.98 Chairman's Welcome and Announcements**

The Chairman welcomed everyone to the meeting

### **22.99 Apologies**

Apologies from Cllr Giles Greenwood were accepted (annual leave)

### **22.100 Casual Vacancy**

There were no expressions of interest in the casual vacancy at this time

### **22.101 Disclosable Pecuniary Interests**

There were no pecuniary interests to record

### **22.102 Dispensation**

There were no requests for dispensation

### **22.103 Report from Shropshire Councillor**

Richard Marshall, Shropshire Councillor for Worfield, said that he did not have a report as such, but would be commenting on the upcoming South Planning Committee due to take place on Tuesday 14<sup>th</sup> March. He said he was disappointed that officers had recommended approval for the solar farm in Kemberton, but noted that officers had to make their comments in line with the national policy framework. The fact that none of us want it has no bearing in planning law. If the plan were not passed it could go to appeal, but if it were passed the only option available would be judicial review and this would cost tens of thousands of pounds.

He advised the Chairman to send a polite email to all members of the South Planning Committee prior to the meeting, not contradicting planning officers regarding planning law but including main arguments against the plans. Cllr Marshall highlighted two main areas of argument against:

- Harm to the Local Economy – the solar farm would be a loss to a local farmer. It is notable that this is an organic farm.
- Green Belt special circumstances - special circumstances are required to build on the Green Belt, renewable energy would qualify as this but it is notable that there is a brown field site very near that is earmarked for commercial use. It would be more expensive.

Cllr Marshall said that his summing up would be to question if maximising the profits of energy companies would be special circumstances for building on the Green Belt.

He concluded by saying that there is a mountain to climb. If the Committee does reject the plan, of which he is about 65% certain, the chances of the planning inspectorate upholding such a decision at appeal he suggests would be more likely around 40%.

The Chairman, Cllr Phil Jones, thanked Cllr Marshall for his support.

## **22.104 Public Participation Session**

There were ten members of the public present and comments were made about the solar farm plans including:

- The farmer is a tenant farmer, this could go against the economic argument as tenancies can be removed
- The system is weighted against residents
- Residents did not have time to respond to the comments made by the company pitching the plans
- Questioning of the potential of a health risk to residents of having solar panels so close to the village
- Questioning the section of the plans that refers to putting the land back to agricultural use in 40 years.
- Beckbury recently had an application refused on the grounds of visual impact before the planning stage

A member of the public asked about the site visit due to take place before the Committee meeting. Cllr Richard Marshall advised that a Parish Council representative taking place could only speak through the Chair as the site visit acted as part of the committee process.

It was noted that residents would need to register to attend the committee meeting. Transport arrangements were being put in place, and the Chairman, Cllr Phil Jones, said that he would contact interested parties with details about registering attendance. A member of the public said that the more people who attended the better, it was questioned how many people could speak. Cllr Richard Marshall said that he would find out this information.

Cllr James Rennison noted that the Parish Plan had indicated that residents did not think renewable energy sites were suitable for Kemberton. Cllr Richard Marshall requested that the Parish Clerk find out who the plan was lodged with at Shropshire Council and if it was formally adopted.

Simon Crothall, as part of the Solar Panel Working Party, had spoken with the solicitor advising the Parish Council. He had looked at the brief again (at no cost) and advised that the options available for further assistance for the Parish Council to consider were either the preparation of a paper to be read at the Committee that condensed documentation, or for him to attend in person. The costing for the paper would be approximately £700 to £1000, whilst attending in person would be £1,500 (excluding VAT).

The Chairman, Cllr Phil Jones, thanked Simon Crothall for all his diligent research and time spent on the Solar Farm.
