



**The Kingsclere Neighbourhood Plan.**

As part of Basingstoke & Deane's Local Plan we need to build 50 new homes in Kingsclere by 2029. We, as a community, have a chance to say where this development takes place as well as what type of development we need by producing a Neighbourhood Plan. This is a community plan so it is really important we find out what you think. These questions are to help us predict what should be built in Kingsclere. Please think what changes will take place in your community in the next fifteen years which will impact on future housing needs.
