

**LENHAM PARISH COUNCIL**  
**REPORT OF THE PLANNING COMMITTEE MEETING AT 7.30pm ON MONDAY 6<sup>TH</sup> JANUARY 2020 IN THE COMMUNITY CENTRE.**

**PRESENT**

**PUBLIC PARTICIPATION**

A representative from Lenham Wanderers Football Club wished to discuss the future of the playing pitches after the proposed sale of the strip of land to Countryside and before the pitches are relocated to land south of Old Ashford Road. Cllr. A Ratcliffe presented a draft site layout which increased the car parking spaces with vehicle access via a gate, which also allowed access for the gang mower; the parking area would have a knee rail to discourage parking on the grass area. There would be a wooden three stock boundary fence along Old Ham Lane and a separate fenced off skatepark/play area to the south west of the site, independently accessed from Old Ham Lane. Full utility services to the pavilion will be retained during the development, drainage issues and car park surfacing were also discussed. The representative was given a copy of the draft plan to discuss further with the LWFC committee members. Cllr. J Britt offered dates for a meeting with the KCC Rights of Way officer to discuss the relocation of a footpath on the land south of Old Ashford Road, allocated for football pitches. The Chairman opened the meeting at 8.15pm.
