The Chair welcomed all to the monthly meeting of Stockton Parish Council

Item 1 Open Forum

There were no items brought forward during open forum

The Chair brought agenda items 15 &16 Forward to accommodate the principal authority member present.

Items 15 & 16.

County and District Cllr. Crump noted that with regard to the refusal of planning permission for the Crown application he will support the Parish Council in how it wishes to act with regard to any decision by the Crown regarding an appeal. Cllr. Crump noted that that the waste bin calendar for one street in Stockton is causing problems and he is attempting to rectify the situation.

Cllr.Crump noted that the District Council will fuel their vehicles with waste vegetable oil on a three year trial basis with a potential saving of £250K per annum.

Cllr.Crump that only 110 parking permits in Stratford for senior citizens have been issued.

Cllr Crump noted that the District Council council tax has been increased by 2 99%

Cllr.Crump noted that under the WFRS proposals the Southam Fire station will be continuously manned during the day.

Cllr.Crump noted that within the Upper Lighthorne development there are problems with the community and medical facilities that were supposed to be available.

Within the County issues Cllr.Crump that the budget will rise by 4.99% for the forthcoming year.

Cllr.Crump asked that all those concerned with the future of the fire and rescue service to respond to the WFRS consultation by the end March 2024. Cllr.Crump noted that inflation has had an effect on the CC budget especially in child and adult social car.

This completed Cllr.Crump's presentation and after being thanked by the Chair left the meeting.

Voluntary Driver scheme: Cllr.Warner noted that this scheme is very good, and noted that others from the village use it.

Grit bins: Cllr.Warner noted that the village grit bins for use on village roads have been used on private drives.

Welshman's Barn: Cllr.Warner noted that now that the trees in hedge have been cut back the barn can be seen from the road and is a part of village history. The Chairman will bring this to the attention of Cemex.

The Stone: CI;Ir Millidge noted that the fencing around the stone in High Street is looking shabby, the Chairman will look it as he passes.

Community Orchards: The Chairman had an email from the County Council about the formation of a community orchard and that Parish Council's can apply for funding, however the Parish Council owns no land for an orchard.

Solar Farm: The Chairman asked the County Council about re-instating their proposal for this but was informed that it was not self-funding, and that there are problems with connection to the national grid.
