- Data Protection Registration This is a required registration with the Information Commissioners office. Proposed by Mrs R Scott, seconded by Mrs V Wright, supported unanimously
- Capital Revenue: Information on the rules pertaining to this were circulated around all Parish Councillors present. This information is to be passed to those not present. There are clear rules on what this can and cannot be spent on

## 8. Youth and Community Centre:

- Repointing conservation grant to be applied for, once quotes received. This includes fascia boards.
- Flat roof over toilet block There is the possibility of a grant to get materials and the Parish Council to pay for the works.
- Insulation –This could be covered by the capital revenue fund as part of a refurbishment project

### 9. Defibrillators

Siting of two defibrillators and security cases in Collingham. The cases are to be put
on the outside of buildings with a trickle charge power supply. The first one is
proposed on the outside of the Fire Station with the second one being proposed at
William Bailey House. Proposed by Mrs R Scott, seconded by Mr T Ozbourne and
supported unanimously. Mrs R Scott to speak to the Fire Service and Mrs V Wright to
speak to Mr Nash to agree proposals.

## 10. Community Park

Meeting with HAGS SMP and the final design has gone out today and a meeting to agree final changes. HAGS SMP was chosen by the village during the consultation process. There is £143,742 of funding from various sources some of which is ring-fenced for specific items

#### 11. Correspondence

- (i) Community Park Art Project on the skate park. Meeting to be arranged with the young man, who has made the proposal, to determine timescale etc
- (ii) Collingham Tennis Club request for monies. Sport England was involved in the initial stages of the planning and the Parish Council was not involved. A letter to be sent to the tennis club. Local sports clubs should be encouraged to find and apply for grants which may be applicable to them, which the Parish Council will support where possible. All local events run by the Parish eg May Fair, advent light all sports clubs have the opportunity to fund-raise. No monies have been given by the Parish Council to other sports clubs in the village.
- (iii) Remembrance Services Churches Together to be attended by Mr C Allen, Mrs V Wright, Mr Tim Musson and Mrs M Parkin. The Balderton Parish Council event at the Air Museum to be attended by Mrs M Parkin. 4 wreaths to be ordered for North Church, South Church, Methodist Church and the Air Museum.
- (iv) Following a letter from a resident about care in the community, it has been noted that the Collingham Parish Council meeting of 26 September 2013, Agenda Item 6 resolved that no further payment would be made to Mr Duffy. Collingham Parish Council has a volunteer policy which is reviewed each year.
- (v) NCC consultation on Nottinghamshire Minerals Local Plan, Additional Consultation on Sand and Gravel Provision Shelford West. All previous comment will go forward. Nothing further to add.
- (vi) Flood Assistance Offer of Community Sandbag Stocks from Nottinghamshire County Council. The possibility of these being stored at the Fire Station to be investigated. Order to be placed for bags if this is possible

(vii) Consultation from Nottinghamshire County Council – Doing things differently – Your money your say. People to be encouraged to participate in this consultation. A number of hard copies were circulated, also available online

## 12. Councillor's reports and items for future agendas:

#### Mrs R Scott

- Robert Jenrick has sent a letter to all parishes for a meet and greet event. The Parish Council Chair can be accompanied by someone who does things for the benefit of the village. Nomination made and all agreed
- Letter from resident on Station Road with regard to the development of land at the back of the scout hut. The development manager at LCS has been contacted to see what is happening as they appear to be using the land. The parcel of land is land locked
- Complaints have been received about footpath No. 37 which runs across the development. This has now been smoothed and rolled
- Trees at the Glebe Field are in hand. The land agent is hoping to have a new tenant, who will be made responsible for the maintenance of the boundary, on both the High Street and the public footpath side of the field
- Newark Art Club celebrating 70<sup>th</sup> birthday and are offering paintings for fundraising purposes
