22/74. Apologies. (1) Cllr. C. Smith-Haynes – unwell

22/75. Declarations of Interest. (2)

No declarations were made.

22/76. Minutes. (3)

Draft minutes of the Parish Council meeting held on 14th July 2022 and copies were circulated. The minutes were approved by members after the clerk was informed of the misspelling of Cllr Currall's surname. This was amended and authorised for signature by the chair. **RESOLVED.**

22/77. Public right to speak. (4)

Revd. Nicki Hobbs join in the discussion below 22/78. The Rector confirmed she will stay on as a trustee for the Bentham Charities.

Alderman Baxter joined in the discussion below 22/78 as he was the chair of Bentham charities for 24 years.

22/78. Bentham Charities. (5)

The Joseph Bentham Charity is an amalgamation of five very old legacies whose objective is to give assistance to the needy in Broughton.

The Charity has four Trustees who are appointed by the Parish Council and one Ex-officio Trustee who must always be the vicar.

The Charity owns parcels of land which are rented out to provide an income for the charity and capital, the interest from which also provides an income.

The parcel of land adjacent to the Traveller site has been rented to the Hoyland family for some years and the family have requested to buy the land. The charity have refused to sell despite being offered what the land agent (Berry's) consider to be more than the true value of the land.

There has been an issue with fly-tipping on the land and the tenancy agreement with the Hoyland family dictates that the charity are responsible for the clearance of the land. The tenancy agreement expires in January and the charity have decided not to renew it.

The distress and anxiety all this has caused has resulted in the decision of all four trustees and the clerk to resign their position in the New Year after the Christmas distribution of funds.

There seemed to have been an assumption on the part of the Trustees that the Parish Council would somehow become responsible for the Charity once they resigned but this is not the case. I spoke to the Charity Commission who advised me that the Trustees have a legal obligation to administer the charity or, if there are insufficient people to do this they must wind up the charity according to the rules set out by the Charity Commission.

I have advised the clerk of this situation. The Parish Council can assist in seeking new Trustees but we have no further obligation as far as I can see and we have no rights over the land or funds.

There is nothing to prevent Parish Councillors from becoming Trustees if they so wish.

It should be noted that when Trustees make decisions it should always be in the best interest of the Charity. When considering whether or not to sell the land the judgement must be whether income from renting the land exceeds the potential income from investing the proceeds from the sale of it. If refusing to sell could be judged as not acting in the best interests of the charity this decision could be challenged under charity law.

Cllrs Bull, Shrive, Rose and Scouse will meet with the charity independently to help with advertising for 4 new trustees and a clerk. Revd. Nicki Hobbs will stay on as a trustee.

Cllr John Currall

Kier Highways contract started on the 12th of September.

NNC will be investing 1.5 Million this year to all the 109 Town and parish councils. The money will be spent on potholes/ vegetation clearing/ sign cleaning/ Road marking etc.

A consultation is taking place on the LCWIP. Local Cycling and walking infrastructure plan.

The executive approved the green waste proposal to charge for this service from April 2023

November.

Cllr Jan O Hara

Cllr O Hara was made aware in the week of the very unfortunate incident that occurred in Carter Ave yesterday, which involved a pack of what were presumed to be Foxhounds ending up chasing a Muntjac deer into the residential area where they proceeded to tear it to pieces in front of some very shocked onlookers.

The bystanders managed to get the dogs off the deer which eventually died and the dogs then ran back in the direction they came from – the back of the garages and into the field where a gap to access the field has been made.

The police were informed and video footage was submitted.

A sincere apology was received from a representative of the Pytchley & Woodside Hunt to the council and confirmation that extra measures have been put in to be sure this type of accident will not happen again and will avoid laying pre-laid scent trails close to the village again.

Cllr Bull remarked on how the children were enjoying playing on the tree in the high street playing fields and all agreed it was a brilliant reuse of the tree. **Dave Lane has confirmed it will remain until it starts to rot.**

Footpath from Hutchinson Avenue to Glebe Avenue is very overgrown and difficult to traverse in a wheelchair reported – Ref 3773090.

Update Oct: Clerk chased but works have not yet been completed. Action: Clerk to chase again.

Footpath from the side of 56 Church Street by the Church to the pocket path. It has brambles and briars at eye height and is becoming quite dangerous reported - Ref 3773119. - Action scheduled

Clerk Report

Clerk has been in contact with Heather Brunsdon, Neighbourhood Manager for Kettering area regarding a willow tree overhanging from a property on Wellingborough Road onto a property on Lime Road. The Grounds Maintenance Surveyor has already been out and has assessed the safety of the tree and has confirmed that although the tree is extremely tall, it is not dangerous in any way. Because of this it does unfortunately mean that from Housing's point of view we are not in a position to enforce the tenancy by insisting that the tenants have to cut the tree down. We can only enforce the tenancy at the point that the tree becomes dangerous or is dead or diseased.

22/82. Reports from other meetings attended (9)

Cllr Pat Scouse report- Electric vehicle charging points

I attended a Zoom conference hosted by NCALC and heard a presentation from Electric Places (formerly Electric Corby CIC) who are helping NNC formulate a strategy to achieve their Net Zero target by 2050 – NN2NZ (North Northants to Net Zero). The meeting was attended by approx. 30 Parish & Town councils.

Peter Stevens and Nick Bolton delivered the presentation which gave an overview of the task and identified the elements of life which are the principle emitters of CO2 in this area – transport and domestic use were top of the list.

The presentation briefly spoke about the potential for reducing CO2 emissions in general but the focus of the meeting was how to reduce the impact of transport, particularly car use.

There were discussions about car sharing schemes and the need for a more comprehensive public transport network throughout the rural areas.

The subject of car charging points was discussed at some length and the variety of solutions available for those without off street parking was explored.

It was agreed that there was sufficient interest among the participants to create an opportunity for further discussion and to gain further knowledge on the subject. NCALC will facilitate this.

A questionnaire will be circulated shortly, hopefully before the next PC meeting to gauge the level of interest among Parishes.

Cllr Robin Shrive report – NCALC AGM 1st October

During the morning session on the cost of living which I attended, the other being the police. A lot of ideas were put forward which included discussions about warm rooms, community kitchens and hubs

- NCALC subs to raise by 8.8%.
- 23-24 precept needs to be carefully thought about. It was suggested not to precept for things that are not essential or help in the current situation.
- There is no charter drawn up yet on how to devolve/sort services in the old boroughs.

Danny Moody given his 15-year award and a 75th anniversary cake was cut.

Danny made a presentation on Northants CALC Past, Present, & Future looking back over the 75-year history of the Association. This had been updated by Eric Franklin from the 2012 edition that he had done.

Jeffery Greenwell presented council of the year to Moulton PC.

The afternoon started with the North and West separating. Mike Scott chaired the panel for North Northamptonshire, the panel comprised of Jonathan Owen CEO of NALC, David Watts Executive Director at NNC, and Chief Superintendent Adam Ward from Northamptonshire Police.

I was able to ask about Highways but got very poor feedback with everything coming back to money. Discussions did then go off in various directions, mainly about the lack of money and the fact that 90 million from NNC's budget is spent on 1% of the population when it comes to Adult Social Care.

It was suggested we should just keep on complaining for new road surfaces.

Other areas like Corby Swimming Pool had gone up in cost three times since the budget was set.

The day was ended with a very good talk on climate change by Ed Gemmell, who is also a Parish councillor on Hazlemere Parish Council. He said that all parish councils should be setting Zero Carbon goals not just for themselves but also there parishes and look at getting solar and wind schemes set up within the parishes.

In summary, I think NCALC are not so much a way of getting change for parish councils but certainly a way of finding things out.

Police been told there is no more money for extra officers.

Village Hall Meeting

Village Hall will submit a planning application for minor alterations to the changing rooms. There was \pounds 6-7k profit from village show.

Need new volunteers. Bringing cleaning contractors in.


22/83. Traffic Calming update 10)

Report produced by Cllr Martin Rose

Broughton PC have been monitoring the speed of vehicle in the village for over a year now and the following is an analysis of the results of this monitoring.

Having looked at the data, we have taken the view that we should ignore anything under 35 as we don't want to skew the figures with people who may be travelling at 31 or 32 etc. We also consider that 35 and above is the point at which speed is becoming a problem that warrants where possible, some form of attention/intervention.

The following pie chart shows the percentage of vehicles exceeding this limit in relation to those checked during the period we have been monitoring, for each of the roads we have checked.



The problem areas are not only clear to see, but exceed the other areas by a considerable margin and as such, are the areas that we feel require prioritisation.

The worst area is Cransley Hill in, followed by Northampton Road in and Northampton Road out.

The proposed reduction in the speed limit on the road from Cransley is likely to impact the Cransley Hill issue leaving, what we have always suspected would be the main concern, Northampton Road. We would hope that any measure put there would solve the "in" and the "out" at the same time. In addition the total number of vehicles travelling into the village via this route is very low.

Whilst Kettering Road out is the 4th highest and has a higher number of vehicles per day, it is going out of the village and slowing down will naturally occur shortly after the speed camera due to the sharp bend before exiting to the A43.

This leaves Northampton Road with the highest number of vehicles exceeding 35 and with the highest speeds of all.

The two areas requiring attention are Northampton Road followed by Kettering Road and the main consideration is what impact we can have with the limited funds we currently have. Some of the measures used in other place look to be more in keeping with what would like and look to be cheaper options than those that have been put forward to date.

A discussion took place which included the fact that resurfacing has not been carried out for years. Alderman Baxter joined in the discussion who advised of his correspondence with an NNC officer because of the fact that Kettering Road has had no works carried out since 1984.

22/84. Community & Police report (11)

There has been some sightings of vehicles parked at the end of the cemetery. The Gate is always open and activity has been sighted there. The clerk has emailed NNC to report but has yet to receive a response.

Action: Clerk to look into pre-made sign which ask people to close the gate

22/85. Old Memorial Gardens (12)

NNC have now installed the ramp in place of the broken steps.

NNC will clear plants/shrubs but are unable to install a power point and water supply. Operation Spring bloom has been discontinued.

A resident has kindly donated £100 in memory of Malcom Darlow and they have agreed to the money going towards the central tree and planting.

Cllr Shrive has paid the money into the bank account and clerk had verified payment.

The crab apple tree which was chosen was a variety called admiration. The clerk investigated different suppliers online for quotes but it was decided that Cllr Bull will contact Bosworth garden centre as larger specimen is required.

Cllrs Bull, Taylor, Rose and Manning met onsite with NNC Officer Dave Lane to discuss their initial thoughts with what they would like to see onsite.

- Agreed shrubs and plants to be removed.
- In addition to the tree, boulders may be relocated and placed as a feature.
- Controlled mowing which would reduce visits leaving longer grass by the banks in the High street park. NNC are going to speak to the residents in the bungalows to clarify intentions.
