

# Minutes of the Meeting of Lenham Parish Council Held on Wednesday 6<sup>th</sup> September 2023 at 7:30pm at Lenham Community Centre

#### **Public participation**

1 member of the public reported/asked, that the weeds outside the WCs are removed, L Westcott advised this was on the job list for the handyman. There is a lack of information on the change to the bus services, LPC agreed to write to express disappointment. Will there be a ceremony for REME's freedom of the parish? Cllr. A Ratcliffe hoped this would be included at the D Day anniversary event in 2024.

1 member of the public attended as a representative of Len Valley Football Club who had applied to LPC for a grant of £500 towards a portable defibrillator. He answered questions from Cllrs. and confirmed it would remain the responsibility of the football club and would be available for other village events.

1 member of the public from Rayner Hills and representing the Ham Lane Allotments Association thanked LPC for their support against the proposed pizza van at Rayners Hill. There has been an issues with one allotment holder who has now left following an eviction notice, 8 remain on the waiting list. An update on the nursery was requested, Cllr. A Ratcliffe reported that there had been no progress since the last report.

The community Warden summarised the current consultation on KCC Community Wardens. Cllr. J Britt urged everyone to respond.

### 23/65 To consider hiring a handyman for 8 hours a week at £20 an hour

The Cllrs. discussed the proposal for a handyman. Cllr. D Earl proposed and Cllr. D Turner seconded and it was **RESOLVED** to agree to hiring a handyman subject to contract agreement.

#### 23/67 To consider proposed road names for "Runham Mews"

Cllr. N Osborne reported that "Mews" usually refers to stables and there has never been a stable at Runham Farm. As the Lady Monckton of Brenchley lived at Runham Farm, the name "Brenchley Fields" was suggested.
