MINUTES

1) Welcome by Chairman: The Chairman welcomed all to the meeting

Apologies: Apologies were received from Councillor M Howorth who has work commitments & Councillor R Ward who had a prior commitment also Councillor K Fulton who had a family bereavement.

3) Declaration of Interest: None at this point

4) Public Session: There were no members of the public present

5) Place Plans: After discussion it was agreed that these should remain as the previous year; proposed by Councillor C Wild; seconded by Councillor R Purslow and agreed by all members present.

6) Shropshire Council Highways Assets Management Strategies: It was agreed that the Council wished to respond by stating that they wished Shropshire Council would maintain the rural highways assets to a suitable standard.

8) LJC: Councillor C Wild reported that a Julian Povey had spoken at the LJC in the NHS and the A & E at Shrewsbury stays open is from the goodwill of the staff as they are able to fully staff them. The parish council felt that both A&E sites should be kept open and staffed to full capacity.
