## Minutes of the Ordinary of the Parish Council held on Tuesday 21st March 2023 at 7.30pm

#### Held at St John's Church, Bishop Thornton.

- (2022-23 140) Present were Cllr Carolyn Sandford (Chair), Cllr Nick Tither (Vice Chair), & Cllr. Kevin Reynard
- (2022-23 141) Also present was David Taylor, Clerk. There were no members of the public.
- (2022-23 142) **Apologies** were received from Cllr. Julia Fulford and Cllr Felicity Cunliffe-Lister (North Yorkshire County Council).
- (2022-23 143) There were no declarations of interest and so no applications for dispensation were required.
- (2022-23 144) It was **resolved** that the minutes of the meetings held on 24<sup>th</sup> January 2023 having been circulated for consideration beforehand were true and correct records. The Chair was authorised to sign them accordingly.
- (2022-23 145) It was **noted** that the meeting held on 24<sup>th</sup> January was inquorate and so it was **resolved** that all "decisions" taken that meeting should be ratified as resolutions.

#### **Reports:**

- (2022-23 146) The Chair **reported** that she has had talks with Clint-cum-Hamlets Parish Council regarding the bin store on Pye Lane, Works on Pye Lane, Thornton Beck and the associated environment and the 20's Plenty initiative. She also attended a meeting of Cayton Cares which was a community project to promote and support lunches and social events.
- (2022-23 147) It was **noted** that the reported a wheelie bin store had been installed adjacent to the roadside on Pye Lane. It obscures the view of the road on an already dangerous part of the road and thus presents a traffic safety hazard. It has attracted 15 complaints from Shaw Mills residents who use the route regularly. It has been reported to the NYCC Highways department and the Police. The Clerk is to write to the resident concerned asking him to remove the bin store.
- (2022-23 148) The Clerk is to send a note of thanks to Mr & Mrs Riley on behalf of the Parish Council with regard to them looking after the bench half way up Mill Bank.
- (2022-23 149) There was no report from North Yorkshire County Council.
- (2022-23 150 There was no report from Harrogate Borough Council.
- (2022-23 151) The Clerk **reported** that the Barclays Bank review is still taking place despite all the information required having been submitted.
- **(2022-23 152)** The Clerk reported on the drop-in session that he attended at Harrogate Borough Council office regarding the new North Yorkshire Council.
- (2022-23 153) It was **reported** that there are no plans, as yet, for activities on the weekend of the Coronation of His Majesty the King on Sat 6<sup>th</sup> May.
- (2022-23 154) It was **reported** that whilst the gritting service provided by NYCC Highways Department is generally very good it was noted that the previous week's cold

snap had been dealt with very poorly, particularly in view of the new system of predicting future requirements using an advanced weather forecasting system that we were informed of. Many road users were stranded, some abandoning their vehicles in and around Bedlam when roads became severely iced up.

(2022-23 – 155) It was reported that the white lines in and around Shaw Mills are now completed. The rumble strips have not however been refreshed and the gulley on the road out of Shaw Mills towards Burnt Yates is, however, still blocked. This causes flood water to run down the hill and in cold weather produces an ice sheet. The Clerk is to report this to Area 6, Cllr Cunliffe-Lister, Michael Harrison, Nigel Smith & Richard Flinton.

(2022-23 – 156) It was noted that somewhere between the IT spell checker and various other documents the spelling of the word defibrillator is inconsistent!. The Clerk shall check the spelling of all references to the word "defibrillator" and use this spelling.

(2022-23 – 157) It was reported that there appears to be a tipping site operating off Watergate Road ( just past the Chequers Public House). The Clerk is to report this to Highways Area 6 and the Environment Agency.

(2022-23 – 158) It was reported that some members are still experiencing difficulties receiving documents from the Clerk. The Clerk is to ask further about Apple products interfacing with Windows 365 products.

It was resolved to publish a leaflet for a door to door delivery advertising :-

- a. The defibrillators, and
- b. That there is a vacancy for a Councillors in the Bishop Thornton ward,

It was resolved to notify Cllr Cunliffe-Lister of the difficulties the Parish Council is experiencing with the developers at High Mill. Perhaps she may wish to attend a site visit.
