- 23.35 Council reaffirmed Declarations of Interest(s)
- 23.36 Public session: There were no members of the public to speak Police Representative present

Following a notice of co-option an application has been received from Linda Bennett. Councillors voted to appoint Linda under co-option rules

LB raised concerns regarding lanes in the village being dangerous to residents due to deep mud and grass verges being eroded into ditches, following the harvesting of nearby fields. This is a particular concern for elderly and vulnerable residents. Access to other fields are also restricted due to this. The mud is too deep even for a 4x4 vehicle. It is felt this road requires major investment – RB to talk to resident and SHJ to raise this at the Multi Agency Meeting
