#### 23/013 PUBLIC PARTICIPATION SESSION - None.

#### 23/014 DECLARATIONS OF INTEREST - None.

**23/015 MINUTES** – It was agreed that the Chairman should sign the minutes of 12th January 2023 as a true and correct record of the meeting.

**23/016 REPORT FROM CLLR. LEZLEY PICTON (SHROPSHIRE COUNCIL)** - Cllr Picton not able to attend due to ill health.

#### 23/017 OTHER REPORTS

- a) **Police** Motorcycle traffic teams have been out and about. Sixteen drivers were caught speeding locally.
- b) SALC PR had attended the online meeting this evening. There was some information shared from the Police and Crime Commissioner. There has been significant progress in combating 'county lines' - bringing the known organisations in this area down from 20 to 4.
- c) **Village Hall** The Arts Alive concert scheduled for this evening has had to be postponed because of the weather new date TBC. There is to be a Fun Day held to celebrate the Coronation. This will be a bring-your-own food/drink, with 1950s music, children's games, etc. There is still a pressing need for more people to join the **Village Hall Committee**, to enable its continued operation.
- d) **Footpaths** The group has met with Huw Williams.

#### 23/018 WEST MERCIA POLICE COMMUNITY CHARTER

Council agreed to submit the following priorities for policing:

- Speeding particularly on Pelham Road.
- Dangerous parking near the school.
- Farm thefts.

The Clerk has also submitted all our meeting dates for the year, with a request for police attendance if possible.

Councillors expressed frustration that the recent police surgery held in the village was not publicised and there was barely any notice given to the parish council. JB had attempted to attend the surgery 15 minutes after its start time, only to find that the officer had already left.

#### 23/019 PROGRESS REPORT

- a) **Village Hall fence** No update yet regarding the fence, as problems with drainage have become a more pressing concern. Huw Williams is able to obtain quotes, but needs a clear specification in order to obtain fair comparisons. AB to work with Huw to procure some quotes for a) wooden rail fencing, and b) metal estate fencing. It is hoped that this will help the Village Hall committee.
- b) **Speeding on Haughton-Astley road** Responses received from WM Police, the Police & Crime Commissioner, and Shropshire Council.

#### 23/020 GENERAL PARISH & HIGHWAY MATTERS

Please note: Most highway and general repair matters are best reported using *fixmystreet.com*. This will usually get the quickest results.

- a) JB reported continuing problems with road surface drainage by the Business Park. The ditch is running clear, but the gullies draining into the ditch (grips) need digging out. DS to report it to Highways via fixmystreet.com.
- b) AP reported that the **church lawnmowers** have all been serviced.
- c) AB raised the ongoing concerns about **pollution of the River Severn**. Although not within the parish, it is clearly a resource much used by locals and visitors alike. There will be meetings held in Shrewsbury – Shrewsbury Town Council and the Environment Agency will be trying to get more support from Severn Trent.
