This DPI includes any beneficial interest in securities of a body where— (a) that body has a place of business or land in the Council's area; and (b) either— (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the Member (or his/her spouse/partner) has a beneficial interest exceeding one hundredth of the total issued share capital of that class.


