

MINUTES FOR THE MEETING OF THE MARDEN PARISH COUNCIL PLANNING COMMITTEE ON 6TH OCTOBER 2015 TO BE HELD IN THE PARISH MEETING ROOM, GOUDHURST ROAD, MARDEN COMMENCING AT 7.30 PM

- 112/15 **PRESENT:** Cllrs Adam, Brown, Mannington (in the Chair), Newton and Reed. The Clerk and one member of the public were also in attendance.
- *113/15* **APOLOGIES:** Cllrs Childs, Tippen and Turner gave their apologies. The Assistant Clerk also gave her apologies.
- 114/15 **APPROVAL OF PREVIOUS PLANNING COMMITTEE MINUTES:** The minutes of the previous meeting held on 15th September 2015 were approved and signed as a true copy.
- 115/15 **DECLARATIONS OF INTEREST:** There were no declarations of interest.
- *116/15* **GRANTING OF DISPENSATION:** There were no requests for dispensation of any item on this Agenda.
- 117/15 **IDENTIFICATION OF ITEMS INVOLVING PUBLIC SPEAKING:** Member of the public did not wish to speak on any item on the agenda.

118/15 PLANNING APPLICATIONS WITHIN MARDEN PARISH:

15/507309/FULL – Dove Cottage, Goudhurst Road Two storey side extension and single storey rear extension. After discussion ClIrs felt that as the dwelling was a replacement of a non-domestic dwelling in the countryside when initially built and which had been extensively extended already they wished the Case Officer to consider whether these additional extensions will have an adverse impact on the open countryside.

 (b) EIA Screening Opinion for the demolition of two properties on Goudhurst Road and the proposed residential development of up to 144 dwellings. These papers were only for information for Parish Councillors however since the agenda was published this application has been withdrawn from Maidstone Borough Council by the applicant.

(c) 15/504749/FULL & 15/504756/LBC – Tanner Farm, Goudhurst Road Construction of a triple garage, conversion of stables to domestic accommodation and of packing shed to swimming pool This application had already been before Parish Councillors but further information had been received from MBC's Conservation Officer - Noted

- (a) Decisions Decision updates received from MBC since last planning committee meeting
- (b) MBC Agendas/Reports received Notification of reports published for the Strategic Planning, Sustainability and Transportation committee.
- (c) Local Plan update MBC had published their Regulation 18 for the Local Plan and the consultation period begun on 3rd October ending on 30th October. Cllr Brown had made several notes from the document which would be circulated to all Cllrs to discuss at Full Council. A formal response to MBC would be made at the Planning Committee meeting on 20th October.
- (d) MBC Planning Committee the next meeting of the Committee is due on 22nd October. An item will be placed on the 20th October MPC Planning Agenda.
- (e) Public Path Diversion/Stopping Up Order KM252 Great Cheveney Farm, Marden consultation to "stop up Footpath KM252 to enable development relating to planning application 14/503724 erection of replacement agricultural building to improve the setting of a Listed Grade II Kent barn (for which permission has been granted) to take place"

Cllrs had no objection to this PROW being stopped up however Cllrs had concern of KM260 and asked the Clerk to contact KCC to regularise this PROW around agricultural buildings.

(a) Update: Cllrs Brown had circulated a further draft to all Parish Councillors and she was thanked for all her work that she had put into this document. Once any comments had been incorporated it was proposed that the draft be sent to Richard Wells to start preparing the final document for submission to The Neighbourhood Planning Independent Examiner Referral Service (NPIERS). Thanks were also expressed by Cllrs to Jacob Smith and Jack Velvick (to pupils on work experience in the Parish Office) who had read the document thoroughly and made suggestions on comments, wording and photographs
