Parish Council Vice Chairman, Cllr. Frank Ball opened the meeting and invited participation from the public.

Report from Wiltshire Council

Wiltshire Councillor, Allison Bucknell was unable to attend but sent in recent information for the Parish.

1. RWB & Cricklade Area Board

- a. Community Safety Group Friday 13th Cllr Shendie Green will attend. General catchup and Police and Crime Commissioner will talk about Youth Commissioners
- b. Area Board meeting Wednesday 18th January 1800 for 1830, Purton Village Hall. Interesting agenda to include Police and Crime Commissioner, John Derryman will be talking about the work they have been doing towards a



co-ordinated approach to speeding across the county and the Emergency Planning Team will be there to talk about what happens in the event of a power cut, amongst other things. Please remember that anybody and everybody can come to the Area Board meeting, it would be lovely to see somebody from LBPC there.

2. Planning Applications

- a. The application for the Wind Tunnel has been refused, primarily due to lack of information particularly around acoustics and traffic.
- 3. Land Slippage, Motorholics. Lyneham Banks.
 - a. On Friday 6th January a further slippage occurred on private land to the rear of Motorholics. This information has been fed to Wiltshire Council who have assessed the area. There is a public Right of Way (The Tops) which may be affected although initial survey says it is fine. I have asked for the senior Rights of Way officer to take a look. There appears to be no movement on the rest of the site so this was localised. The Ground Investigation work is complete and options are being drawn up.

4. Hollow Way

a. I saw reports on FB about an incident involving a local resident and a motor vehicle on Hollow Way. There was call for a footpath to be put it. This has been looked at many times before by Wiltshire Council and the Parish Council. I have suggested a meeting with the Chair / Clerk in the first instance to review where we are with all of the various previous proposals.

5. Preston Lane

a. A number of residents are very unhappy about the state of Preston Lane which has taken a real battering of late, mainly at the hands of Thames Water. There is another leak there which is damaging the road surface. I am arranging a meeting with the Highways Engineer to walk the route to see what can/could/should be done.
