Councillors further approved an additional £159.00 to be paid to Cllr. Mr. T. Earp for continued work on the playground railings.

Councillors acknowledged receipt of the external auditor report and agreed to pay the ICO (information commissioner's office) via Direct Debit from next year, saving £5.00 annually. It was further noted that the council has spent 81% of the 2019-20 budget, councillors were made aware that only £1000 was budgeted for street light repairs and this has already been spent with more repairs due. The playground budget has also been spent, but there is unlikely to be significant further spending on the equipment.

The 2020-21 budget will be discussed at the next meeting.

8. To consider donation to Tenbury Swimming pool: It was agreed that the council does not have the fund at the moment, having spent 81% of the 2019-20 budget so far.

9. Village Hall: It was confirmed that the village hall is not VAT registered. Bookings are decreasing due to the cleanliness of the facility and also thought to be difficulties in making contact with the hall. This is being monitored carefully by the village hall committee.

10. Planning – There were no current applications to discuss.

Everyone had read the correspondence – RM to look into the grave query. It was decided that the council could not afford to replace the lantern lights in one go. The oak tree sapling would depend on the area for planting.
