# 152 Budget Allocation for Shaw Hedge Road Play Equipment

The Town Clerk provided an update and reported that along with our contribution, Councillor Yarranton had used some of his divisional funding which meant that Wyre Forest Community Housing (WFCH) match funded the project with £3000. WFCH had also repaired the skate park which had previously caused concern.

## **AGREED**

(i) that the £2000 be released to the TCC in relation to the play equipment they wish to purchase for Shaw Hedge Road Play Area;

(ii) that the Town Council are credited for this contribution and invited to any unveiling event.
