

# REGISTER OF MEMBERS' INTERESTS GENERAL NOTICE OF REGISTRABLE INTERESTS

UNDER THE LOCAL GOVERNMENT ACT 2000 AND THE LOCAL AUTHORITIES (MODEL CODE OF CONDUCT) ORDER 2007 (AS APPLICABLE TO PARISH AND TOWN COUNCILS)

Under the above legislation Councillors are required within 28 days of the authority's code of conduct being adopted or within 28 days of their election or appointment to office (if that is later), a member must register their financial interests in the authority's register by providing written notification to the monitoring officer.
