## 2.4 Email Enquiry

I emailed you in November 2024 and again in February this year to seek your advice on this issue (see below).

Its concerning that it is taking you a year to respond or even confirm receipt of these messages, especially as I described to you a daily issue that we and other families in Awbridge are facing.

This matter has become urgent again - as it does at this time of year - with limited light and invariably inclement weather conditions, at the times of day that we are navigating the 'fastest' part of Danes Road which has no streetlights, pavement or traffic slowing in place. We have had several near misses when walking to/ from the bus stop at Awbridge crossroads and the children have experienced verbal abuse from drivers who slow down only to shout out their windows that they shouldn't be walking there. As you know from my previous correspondence, we have little choice.

I wonder if, now Awbridge Danes has built a few large houses opposite the end of Newtown Road, residents there will also require a pavement/ crossing to safely get to all the village facilities?

I look forward to hearing back from you presently.
