Apologies were received and accepted from Councillor Bexson.

C/119/22. Declarations of Interest or Dispensations from Councillors Relating to this Meeting. The Chairman declared an interest in planning application 22/02120/APP and took no part in any discussion. Councillors Lott and Roach declared they are allotment tenants.

C/120/22. To receive Reports from the Buckinghamshire Councillors.

Councillor Brazier explained there are Community Board Mini Grants available for £1,000 and he encouraged community groups to apply.

The Freight Strategy is due to be signed off in July and is expected to be implemented in September. The Chairman questioned when the double yellow lines will be implemented between 5th-12th September. The application for the brook work has been approved by the Community Board.
