#### Location: 32 The Boundary, Langton Green Royal Tunbridge Wells Kent

Proposal: On going maintenance, cleaning and removing superfluous growth and reshaping. 20% reduction to mitigate health and safety risks resulting from predicted increasing strength and frequency of high winds. Decision: Remain neutral leave to Tree Officer. We do not understand the comments "Due to subsidence of neighbours property" in relation to pruning of the tree.

#### Location: 1 Hither Chantlers, Langton Green Royal Tunbridge Wells Kent

Proposal: Construction of single dwelling (amendment to TW/09/03859/FUL) – To include three additional dormer windows to rear elevation. Decision: Remain neutral leave to Planning Officer

#### TW/10/01164/REM/CT2

#### Location: The Spinney Penshurst Road Speldhurst Royal Tunbridge Wells Kent

Proposal: Reserved Matters (all Matters Reserved); 2 storey small two/three bedroom cottage in front of part site.

Decision: Remain neutral leave to Planning Officer. Concern has been expressed concerning the threat to the well being of the yew tree. Could consideration be given to realigning the drive and planting a deciduous tree in place of the cedar?

Location: Langton Lodge, The Green, Langton Green Royal Tunbridge Wells Kent Proposal: First floor extension and internal alterations Decision: Remain neutral leave to Planning Officer

#### TW/10/00956/LBC

Location: Langton Lodge, The Green, Langton Green Royal Tunbridge Wells Kent Proposal: First floor extension and internal alterations Decision: Remain neutral leave to Conservation Architect.

#### TW/10/01213/FUL

Location: Spar Food, Langton Road, Langton Green Royal Tunbridge Wells Kent Proposal: Change of use of one shop unit to single bed roomed ground floor flat with very small bathroom extension
