# **Eastling Parish Council**

Minutes of the Meeting of the Parish Council held in Eastling Village Hall on 11 March 2025

Present: Cllr Julia Bailey (Chairman), Cllr Caroline Gilbert, Cllr Barrie Neaves and Cllr John Payne; and Mrs Wendy Licence (Clerk).

Also present were two members of the public.

Cllr Bailey welcomed everyone to the meeting

#### 1. Apologies

Apologies had been received from Cllr Annie Adams (holiday); apologies accepted. Apologies had also been received from County Councillor Rich Lehmann (at another meeting); apology noted.

#### 2. Declarations of interest

None were declared.

### 3. Minutes of the Parish Council Meeting Held on 14 January 2025

It was **AGREED UNANIMOUSLY** to accept the minutes as a true record of the meeting. The minutes were duly signed by Cllr Bailey

### 4. Matters Arising from the Minutes

Cllr Bailey said an alternative proposal had been put forward for the village green space but this was rejected by the Village Hall Management Committee.

# 5. Public Time

The meeting was adjourned for the public time.

A member of the public asked if there had been any feedback regarding the proposed village green space.

Cllr Bailey said there had been no formal response.

KCCllr Lehmann was unable to attend the meeting but had submitted the following report: Swale Borough Council will be hosting a public meeting this coming Wednesday about Local Government Reorganisation.

The government's aim is for Kent to be turned into Unitary Authorities in the next two to three years. This will mean Kent County Council and Swale Borough Council would become part of a larger Unitary Authority responsible for all of the services Kent County Council and Swale Borough Council currently provide.

The authority we become part of will cover a massive area (probably 3-4 times larger than Swale), and both residents and councillors could easily end up finding themselves with less power and less of a voice to represent their local area.

Current possible options for the reorganisation could see Swale grouped in with Medway, Gravesham and Dartford, or possibly with Canterbury and Ashford (or even Canterbury, Ashford, Thanet, Dover and Folkestone).

To hear more about these plans, and to share your views, please go along to the meeting on Wednesday evening. For those not able to make it to Sittingbourne, the meeting will also be broadcast on Swale Borough Council's YouTube channel.

Cllr Bailey said it was known that KCCllr Lehmann is opposed to the change in Local Government. Kent Council Council's bid to be fast tracked to a Unitary Authority was unsuccessful.

Cllr Neaves said that the presentation by Swale Borough Council suggested that some parishes may merge.

The meeting was reconvened.

#### 6. Chairman's Report

Cllr Bailey reported that it has been quiet in the village. Mr Binder is concerned that someone has cut the gas pipes on the bird scarers.

A resident raised concern that lights have been seen coming across the fields.

ACTION: Clerk to circulate details of Operation Galileo.

Cllr Gilbert said flytipping continues to be a problem.

Cllr Bailey said that most has been cleared quickly.

Cllr Neaves said the rubbish at the bottom of Mill Lane has been there since November and has been added to. It is on private land and down to the Belmont Estate, the landowner.

Cllr Gilbert informed Members that she had reported this, there is also asbestos in the rubbish. *ACTION: Clerk to contact Ward member Terry Thompson.*
