#### 1. Apologies

### 3. Minutes of the last meeting

The minutes of the meeting held on 23 September 2021 were approved and signed.

### 4. Regulations

- 4.1 The review of the Burial Ground Regulations were carried out without amendment. PROPOSED Cllr Mrs Brammer SECONDED: Cllr Mrs Clucas and AGREED.
- 4.2 The review of the Memorial Garden Regulations was carried out without amendment. PROPOSED: Cllr Mrs Connell SECONDED: Cllr M Manley and AGREED.

## 5. Memorial Garden

- 5.1 It was NOTED that VAT should be charged on the price of plaques. We do not have to re-invoice the plaques that have been installed, the price will be accounted for including VAT, and this will be reviewed when the prices are reviewed next year.
- 5.2 It was NOTED that a second column of plaques has been started.

#### 6. Future Provision

6.1 It was NOTED that there are 4 burial spaces left in the burial ground.

## 7. Maintenance

- 7.1 It was NOTED that the contractor has removed the ash saplings from graves and sprayed the edges of the paths and overgrown graves with weed killer.
- 7.2 Members were taken through the photographs. Letters will be written to grave relevant grave owners.

- 7.3 Ash Church Mrs Richardson talked members through the compost and litter bin in the churchyard. Cllr Mrs Brammer PROPOSED that a roll of black bags and a bundle of garden sacks are given to the church to help with the waste. SECONDED: Cllr Mrs Clucas and AGREED. As the majority of both the green and general waste is generated by the Burial Ground, Cllr M Manley PROPOSED that the provision of a waste bin for the Burial Ground is revisited and quotes brought to the next meeting. SECONDED: Cllr Mrs Connell and AGREED.
- 7.4 It was NOTED that there are moles in the Burial Ground.
