

Minutes of the Annual Meeting of Lenham Parish Council Held on Wednesday 10th May 2023 at 7:30pm at Lenham Community Centre

Public participation

A member of the public reported that a streetlight was not working near the community centre, no 0010.

A member of the public raised concerns regarding a planning application for their neighbouring property – will be invited to speak when item reached on agenda.

A member of the public reported that the Ham Lane allotment association will be sending a letter to LPC regarding the increasing waiting list for allotments and request consideration for further provision. He also reported that there is a large amount of scrub and vegetation grown up around the LPC end of the site.

23/01 Election of Parish Council Chairman

Cllr. A Walmsley and Cllr. K Hammond seconded and it was **RESOLVED** unanimously to co-opt Mr Paul Culver as a member for the North Ward. The declaration of acceptance was signed by Paul Culver and witnessed by the clerk. The chairman welcomed Cllr. P Culver to join the council as a representative of the North Ward.

23/07 Formation of Committees

23/08 Delegation arrangements for committees and their Terms of Reference

The Terms of Reference for the F&GP committee was reviewed – all agreed to its adoption.

The Terms of Reference for the P&I committee was reviewed – all agreed to its adoption, Cllr. N Osborne asked that all planning applications are referenced on the agenda for discussion even if it leads to a "no comments" submission.

Cllr. S Heeley arrived.

23/09 Councillor Responsibilities – review existing and vacant responsibilities

All agreed to keep existing responsibilities as listed. M Ballard was LPC's nominated trustee for the Alms Houses, it was discussed if LPC needed a current cllr. as M Ballard is no longer a cllr. **ACTION** L Westcott to review.

Cllr. J Britt stated that a formal relationship is required with LWFC considering the works soon to be completed at the WPF. L Westcott reported that there are a number of responsibilities that are not currently covered including tourism - Cllr. D Turner is interested in leading on this and recruitment – Cllr. D Earl is interested in leading on this.

ACTION L Westcott to list those responsibilities requiring lead cllrs. for discussion in June.

23/10 Appointment of representatives for KALC, Community Centre and Alms Houses

Cllr. K Hammond will continue as KALC representative.

Cllr. K Hammond will continue as Lenham Community Centre representative.

23/11 To consider adoption of the Council's updated Standing Orders 2023

Cllr. A Ratcliffe proposed and Cllr. A Walmsley seconded and it was **RESOLVED** to adopt the updated standing orders 2023.

23/12 To consider the adoption of the Council's update Financial Regulations 2023

Cllr. A Ratcliffe proposed and Cllr. K Hammond seconded and it was **RESOLVED** to adopt the updated Financial Regulations 2023 subject to slight rewording of section 1.1.1 for clarification.

23/13 To sign as correct the minutes of the Parish council Meeting on 5th April 2023

Cllr. S Heeley proposed, Cllr. N Osborne seconded and it was **RESOLVED** that the minutes of the meeting held on **Wednesday 5th April 2023** are a true record and were approved, adopted, and signed by the Chairman of the Parish Council.

23/14 Progress on Resolutions from 5th April meeting.

- a. Cllr. A Ratcliffe is still having issues with Unity banking and apologised to Cllr. N Osborne that he hasn't authorised his payment yet. L Westcott reported that it is hoped that all members of F&GP will have banking authorisation to avoid these issues in the future.
- b. An updated on the payment card application will be requested from the RFO at F&GP
- c. The S106 application for funds for the footpath works still needs completion.
- d. L Westcott will liaise with the owner of Forge House about the trees on their boundary with the churchyard.

J Bate has provided a written report. There are no payments to approve, these will be done at F&GP.

Cllr. A Ratcliffe proposed, Cllr. N Osborne seconded and it was **RESOLVED** that the minutes of the F&GP meeting held on Wednesday 19th April 2023 are a true record and were approved, adopted and signed by the Chairman of the F&GP Committee.

a. Cllr. A Walmsley proposed, Cllr. D Turner seconded and it was **RESOLVED** that to authorise payment of £500 towards the coronation event being held at the church.

23/17 To Receive the reports and minutes of the Planning & Implementation committee meeting on 25th April 2023

Cllr. J Britt proposed, Cllr. N Osborne seconded and it was **RESOLVED** that the reports and minutes of the P&I meeting held on Monday 25th April 2023 are a true record and were approved, adopted and signed by the Chairman of the P&I Committee meeting.

- a. 3 Chilston Road all agreed to object to the planning application. The draft response was reviewed, the main objection is over development of the area.

Cllr. K Hammond proposed, Cllr. A Ratcliffe seconded and it was **RESOLVED** to pay the clerks membership to SLCC for £237.

L Westcott provided an update on the plans and booked groups.

Cllrs. discussed the issues with allotment provision. Cllr. K Hammond suggested contacting Bretts who own land in Lenham Heath to review this as an option.

- a. Cllr. N Osborne reported on the works required at the picnic site, quotes are being obtained.
- b. Cllr. P Culver reported that the primary school extension is planned for 25/26

- Cllr. J Britt also reported on the dates for the Maidstone Local Plan Review Stage 2 hearings.
- Cllr. P Culver reported that there is a Primary school governors meeting on 22nd May.

A consultation on a street traders licence application has been received – this was not in time to be published on this agenda, so will have to be discussed at F&GP as MBC will not allow an extension to the consultation period. An email has been received from Countryside requesting our decisions on where the play equipment at the WPF during the widening of Old Ham Lane.
