<u>Trade Union Membership</u> Membership of any Trade Union	<i>none</i>
<u>Sponsorship</u> Any payment or provision of any other financial benefit (other than from the Council) made or provided within the relevant period ³ in respect of any expenses incurred by you in carrying out your duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.	<i>none</i>
<u>Contracts</u> Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest ⁴) and the Council — (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.	<i>none</i>
<u>Land</u> Any beneficial interest in land ⁵ which is within the area of the Council.	<i>none</i>
<u>Licences</u> Any licence (alone or jointly with others) to occupy land in the area of the Council for a month or longer.	<i>none</i>

⁴ "body in which the relevant person has a beneficial interest" means a firm in which you or your partner is a partner or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest; and "director" includes a member of the committee of management of an industrial and provident society

⁵ "land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

<p><u>Corporate tenancies</u></p> <p>Any tenancy where (to your knowledge)— (a) the landlord is the Council ; and (b) the tenant is a body in which you or your partner has a beneficial interest.</p>	<p><i>none</i></p>
<p><u>Securities</u></p> <p>Any beneficial interest in securities⁶ of a body where— (a) that body (to your knowledge) has a place of business or land in the area of the Council ; and (b) either— (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>	<p><i>none</i></p>

NOTES ON SENSITIVE INTERESTS

An interest is sensitive if its nature is such that you, and your Monitoring Officer, consider that its disclosure could lead to you, or a person connected with you, being subject to violence or intimidation
