Minutes of a Planning Committee Meeting held on Wednesday 2nd October 2019 at 7.30pm in the Gallery Room, Langton Green Village Hall

- 1. **To enquire if anyone present intends to film, photograph and/or record the meeting:** No one present intended to film, photograph and/or record the meeting.
- 2. To receive and approve apologies and reasons for absence: there were none.
- 3. **Disclosures of Interests**: there were none.
- 4. **Declarations of Lobbying**: there were none.
- 5. **Minutes: RESOLVED** that the minutes of the Planning Committee meeting held on 10th September 2019 be approved as a correct record and signed by the Chairman.

6. Matters Arising:

- a) Site notices it was agreed to monitor the situation for the time being. It was considered that Councillors are visiting sites before the notices have been put up and Cllr Ellery advised that this information could be found on the TWBC website.
- b) 31 Hither Chantlers the Assistant Clerk had spoken to the TWBC Tree Officer who advised the removal of the trees in question was part of a longer-term woodland management plan.
- c) The Assistant Clerk had written to TWBC regarding mis-placed site notices and in particular one which Cllr Barrington-Johnson had noted on Holmewood Ridge. They had responded advising that in total four site notices were put up in the local area regarding this application.
- d) Lawful Development Certificate for additional parking area adjacent to the pavilion: Cllr Barrington-Johnson had drawn a plan of the proposed area and Cllr Mrs Price and the Assistant Clerk would submit the application.

Proposal: Demolition of two existing houses and the erection of six 3-bedroom homes and four 4-bedroom homes, plus associated access, parking and landscaping.

17/04294/FULL

Location: Land Adjacent Keepers Cottage, Burnt House Lane, Speldhurst

Proposal: Construction of 4m wide by 25m long loading bay with a 10m bell mouth entrance to Shadwell and Sprouds Wood, including replacing hedgerow, replacement gate and erection of fencing.

Proposal: Erection of a second storey rear extension. Decision: Remain neutral, leave to Planning Officer.

Location: Waterfrets Farm, Burnt House Lane, Langton Green, TN3 OJR

Proposal: Change of use and conversion of a redundant agricultural building into a dwelling house

including the provision of a garden area and associated landscaping.

Decision: Remain neutral, leave to Planning Officer but it is not clear where the garden would be and its possible impact on the AONB.

Location: 1 Upper Stephens, Langton Green, Tunbridge Wells, Kent TN3 OBS

Proposal: Trees; LIME (T1) - Reduce branch work by approx 1-2m to re-balance & thin. COPPER

BEECH (T2) - Canopy raise branches inside garden to a height of 3m.

Decision: Remain neutral, leave to Tree Officer.

Location: Speeds Farm, Farnham Lane, Langton Green, Tunbridge Wells, Kent TN3 0JT

Proposal: Redevelopment of site to provide 8 dwellings including alterations to site access road.

Decision: Remain neutral, leave to Planning Officer.

Location: Land Adjacent to Rust Hall, Langton Road, Langton Green, Tunbridge Wells, Kent TN3 0BB

Proposal: Tree in a conservation area notification OAK (TG4) - 2 stems closest to property, fell. Decision: Remain neutral, leave to Tree Officer provided there is a valid reason to fell.

Proposal: TREES: OAK (T1) - Reduce by 40%; OAK (T2) - Reduce laterals to match T1; OAK (T3) -

Reduce lowest bough by around 3m.

Decision: Remain neutral, leave to Tree Officer.

Location: 138 Southwood Road, Rusthall, Tunbridge Wells, Kent TN4 8UX

Proposal: Installation of a 10ft x 8ft wooden shed to replace one private parking space within a

communal parking area.

Decision: Remain neutral, leave to Planning Officer. We suggest a temporary permission to avoid loss of the parking space.

Location: Salomons Estate LTD, Broomhill Road, Royal Tunbridge Wells, Kent TN3 0TD

Proposal: TREES: POPLAR (T1) - Reduce crown to south-west only by 30%; SWEET CHESTNUT (T2) - Fell; ASH (T4) and SYCAMORE (T5) - Prune to provide 3m clearance of building; SWEET CHESTNUT (T6) - Prune to provide 3m clearance of garage

Decision: We object. We note that the application has been amended but it is not clear what the changes are and why they are being made. Our previous comments still stand.

Location: White Moor, Stonewall Park Road, Langton Green, Tunbridge Wells, Kent TN3 0HD Proposal: Demolition of existing detached garage and erection of single storey rear extension and

loft extension, erection of two storey side extension with internal garage.

Decision: Remain neutral, leave to Planning Officer.

Proposal: Loft conversion with roof lights and roof terrace.

Decision: Remain neutral, leave to Planning Officer.

Location: 27 Asher Reeds, Langton Green, Tunbridge Wells, Kent TN3 OAL

Proposal: Erection of single storey front extension. Decision: Remain neutral, leave to Planning Officer.

Location: Maplefield, Ewehurst Lane, Speldhurst, Royal Tunbridge Wells, Kent TN3 0JX

Proposal: Garage conversion and extension to form recreational family space and pool building.

Decision: Remain neutral, leave to Planning Officer.
