Medway Council's Local Plan**

**indicates possibility for building 600 houses**

- ◆ **Dangerous for pedestrians as there is no footway on B2000**
- ◆ **More flooding on B2000 – fields concreted - less drainage**
- ◆ **Longer waiting times to see your GP (already lengthy enough)**
- ◆ **Lack of local school places for your children**
- ◆ **Increase in global warming due to loss of green space areas, contrary to government policy**
- ◆ **Loss of agricultural land & peaceful rural surroundings**
- ◆ **Brown Field space available in UK for 1,000,000 houses**
