Minutes of meeting of Buckland Parish Council On Monday 10th February 2025

25.17 Apologies:

Apologies were received from Buckinghamshire Councillor Mike Collins.

25.18 Declarations of interest

There were no declarations of interest.

25.19 Open Forum

Residents of Monks Court have raised an issue relating to access to Monks Court since concrete bollards have been installed on the BOAT between Puttenham and Buckland in July 2024. The concrete bollard at the Buckland entrance has now been removed by Buckinghamshire Council. The issue initially arose when residents were awaiting a gas delivery at the end of 2024 and the supplier refused to cross the canal bridge due to the weight restriction of 10 tonnes that was issued in 2018. This gas has now been delivered over the bridge. Residents are switching to oil heating to prevent further issues. It has since become apparent that the fire brigade would not be able to access the properties due to the weight restriction and also the risk of grounding on top of the bridge. They have now requested access via Puttenham. There is a bridge in Puttenham which has a lower weight restriction of 7.5tonne with the exception of lorries. The concrete bollards prevent access and the residents are requesting their removal for health and safety reasons.

Chairman confirmed that Buckland Parish Council had investigated possible solutions including removal of bollards and writing to Dacorum Council regarding the issue. Resident thanked BPC for their support.

25.20 Minutes

25.25 Roads and Transportation

- Monks Court Access It was agreed to support the residents on health & safety grounds for removable bollards to be installed.
- Buckland Road Complaints have been received from residents about the increased number of vehicles and the speed of drivers since the installation of traffic calming on London Road, Aston Clinton. The clerk has contacted Cllr Steve Broadbent following on from Truvello data report. ACTION: Clerk to contact Cllr Steve Broadbent with request for traffic islands at the side of road. Clerk to report pothole on corner of Buckland Road.
- Tring Hill and Buckland Wharf update Clerk reported that there had been no reply from Richard Barker to letter send on 27th January. ACTION: Clerk to forward copies to Cllr Steve Bowles.

25.26 Devolution update/Grass Cutting Contract

Clerk met with Amersham Town Council to discuss grass cutting in Burial Ground and All Saints Church yard and is awaiting a quote.

25.27 Maintenance of Land Holdings

To receive reports and agree any actions relating to the Parish Council's Land Holdings:

- Community Orchard Trees donated by Aston Clinton, Buckland & Drayton Beauchamp horticultural society have been planted. The padlock has been removed from the gate. Clerk investigating cost of signage asking users to keep dogs on leads along with a sign saying community orchard.
- Buckland Burial Ground/All Saints Churchyard
 Clerk met with Rev Bottomer to discuss churchyard maintenance. BPC is only able to cut
 the grass in the churchyard four times per year. Rev Bottomer looking into community group
 to help with churchyard maintenance.

25.28 Footpaths and Environment

To receive reports and agree any actions:

- Roadside Hedgerows The chair reported that some residents have complained about state
 of verges and hedges in the village and perception that funds are being spent on Community
 Orchard instead of verges etc. Chair explained to residents that all expenditure on the
 Community Orchard is from grants and these would not cover grass cutting and hedge
 maintenance. Local farmers have been cutting hedges although there are still some
 remaining. Council agreed to spend £780 + VAT for clearance of trees and foliage on verge
 by Church Farm.
- Footpaths Stile has been removed at Lower Buckland. The landowner is concerned that livestock may get onto road. This was reported to Buckinghamshire Council in October 2024 and re reported recently. **ACTION: Clerk to source quote for work to be carried out.**
