APPLICATIONS FOR PLANNING PERMISSION

DC/22/01361 – Application for Listed Building Consent -Replacement of 1no gable dormer window with a timber, flying mullion in keeping with the style of the building - 10 Hawks Mill Street Needham Market IP6 8AA The Planning Committee voted to recommend Refusal for this application. Reason; the proposed window shown on the drawing is a double hung box framed sash window which is totally out of keeping with the other windows in the property which are full height side hung casements.

DC/22/01524 - Application for Listed Building Consent - Replacement of sole plate, Insertion of missing stud and re-render ground floor street elevation - 126-128 High Street Needham Market Suffolk IP6 8DW

The Planning Committee voted to recommend Approval for this application.

DC/22/01530 - Full Planning Application - Installation of a solar array, associated infrastructure and construction of new vehicular access - Land at Woodlands Farm Stowmarket Road Badley Suffolk

The Planning Committee voted to recommend Refusal for this application. This was on a count of votes. Reason; the solar array is not large enough to contribute sufficient energy to justify this loss of valuable farm land.

The application was discussed in some detail with the reason for the application being understood and the decision resting on a single deciding vote.
