#### 148 **Public Forum**

- 2 members of the Friends of the Trent Vale Trail spoke about the proposed route from Collingham to link the NCN64 to the NCN 647. A formal constitution has been agreed, bank account is now in place – Phase 1 is Collingham to Besthorpe for which a detailed plan is being prepared, in readiness for putting out a tender for the construction of this phase of the project. There are currently some land issues that are being worked on with both NCC and Tarmac. A crowd funding site has been set up to support the project.
- A member of the public queried the station car parking charges which have increased. Cllr Scott advised that this issue has been raised with all 3 potential franchisees by the Stakeholder Group and as yet, no response has been received.
- Sherwood Forest hospitals AGM was held at the beginning of this week there was no one else there, which was disappointing. Cllr Barrie advised that many members were actually in attendance at Kings Mill rather than being present in Newark
- A Chairman of Collingham Angling Association was in attendance at the meeting and provided guidance and key knowledge to councillors on the complexities of the Hydropower Electricity Generating Station planning application and the implications of a development of this size and nature in the rural landscape

Pleased that the Trent Vale Trail is progressing, any assistance that can be offered would be appreciated.



A meeting has been held at William Bailey House to discuss the rumour about the bus service being cut. This is not the case and as soon as a new contract is confirmed, an update will be provided, but at the moment there is no proposal to cut any services.

Low Street resurfacing is to be undertaken in this financial quarter.
Clifton and South Scarle are to undergo some surfacing work in October.
NSDC are running a "Green and Clean" project, which includes litter picking and equipment can be applied for as part of the project.
