# LILLESHALL NEIGHBOURHOOD PLAN BASIC CONDITIONS STATEMENT

## INTRODUCTION

This Basic Conditions Statement has been produced to explain how the proposed Lilleshall Neighbourhood Plan (LNP) has been prepared in accordance with the Neighbourhood Planning General Regulations 2015 and how the basic conditions of neighbourhood planning and other considerations as prescribed by Paragraph 8(2) of Schedule 4B to the Town and Country Planning Act 1990 have been considered to have been met.

The Statement addresses each of the four 'basic conditions' required of the Regulations and explains how the submitted Neighbourhood Plan meets the requirements of paragraph 8(2) of Schedule 4B to the 1990 Town & Country Planning Act.

The Regulations state that a Neighbourhood Plan will be considered to have met the basic conditions if:

- having regard to national policies and advice contained in guidance issued by the Secretary of State, it is appropriate to make the neighbourhood development plan;
- the making of the neighbourhood development plan contributes to the achievement of sustainable development;
- the making of the neighbourhood development plan is in general conformity with the strategic policies contained in the development plan for the area of the authority (or any part of that area); and
- the making of the neighbourhood development plan does not breach, and is otherwise compatible with, EU obligations.

## Supporting documents and evidence

The LNP is supported by this Basic Conditions Statement, a Consultation Statement and a thorough evidence base.

## Key statements

Lilleshall Parish Council is a qualifying body and entitled to submit a Neighbourhood Plan for its own parish. The LNP expresses policies that relate to the development and use of land only within the neighbourhood area.

The neighbourhood area is contiguous with the parish boundary, as shown in the map accompanying the neighbourhood area designation application.

The LNP covers the period from 2017 to 2031.

No provision for excluded development such as national infrastructure is contained within the Neighbourhood Plan.

The LNP does not relate to more than one neighbourhood area. It is solely related to the area of Lilleshall as designated by Telford & Wrekin Council in June 2016.

There are no other Neighbourhood Development Plans in place for the Lilleshall neighbourhood area.

## CONFORMITY WITH NATIONAL PLANNING POLICY

It is required that the Lilleshall Neighbourhood Plan (LNP) has appropriate regard to national planning policy. This is principally provided by the National Planning Policy Framework (NPPF).

The NPPF in sections 183-185 refers to Neighbourhood Development Plans and seeks those plans to have regard to the policies in the NPPF and to be in 'general conformity' with the strategic policies of the Local Plan.

This section demonstrates that the LNP has regard to relevant policies within the NPPF in relation to:

- Building a strong, competitive economy
- Ensuring the vitality of town centres
- Supporting a prosperous rural economy
- Promoting sustainable transport
- Delivering a wide choice of high quality homes
- Requiring good design
- Promoting healthy communities
- Meeting the challenge of climate change, flooding and coastal change
- Conserving and enhancing the natural environment
- Conserving and enhancing the historic environment

The LNP has 13 principal objectives. We summarise them in Table 1 below and which NPPF goals each objective seeks to address.

Table 2 then provides a summary of how each policy in the LNP conforms specifically to the NPPF.

As demonstrated in Table 3, the strategic objectives of the Neighbourhood Development Plan are considered to comprise a balance of social, economic and environmental goals.

Lilleshall Parish Council considered that a Strategic Environmental Assessment (SEA) was not required because the LNP is not likely to have a significant impact upon the environment.

### **GENERAL CONFORMITY WITH THE STRATEGIC POLICIES OF THE DEVELOPMENT PLAN**

The development plan currently consists of the following:

- The recently adopted Telford & Wrekin Local Plan 2011 – 2031

The LNP has been prepared alongside the new Telford & Wrekin Local Plan and conformity is judged very much against these policies as a pragmatic approach thus avoiding built in obsolescence for the LNP. It remains a requirement of the Basic Conditions however that general conformity must be with the **development plan** which is now just the Telford & Wrekin Local Plan 2011-2031 having superseded the Telford & Wrekin Core Strategy 2006 – 2016 and the saved policies of the Wrekin Local Plan 1995 – 2006, the focus of attention has been on conformity with policies in the emerging Telford & Wrekin Local Plan and NPPF.

The policies of relevance are shown in Table 4 below, along with a consideration of whether they represent the strategic policies of the development plan. Where they do, consideration is made of whether the LNP is in general conformity with them.

Any policy that is not identified in Table 4 is not considered to be relevant to the LNP because the LNP does not have any policies that directly relate to it.

It is confirmed that there are no policies in the 2000 Shropshire County Council and Telford & Wrekin Minerals Local Plan that the LNP policies have any relevance to.

## **DOES NOT BREACH, AND IS COMPATIBLE WITH, EU OBLIGATIONS AND HUMAN RIGHTS REQUIREMENTS**

The Neighbourhood Development Plan has regard to the fundamental rights and freedoms guaranteed under the European Convention on Human Rights and complies with the Human Rights Act.

In November 2016 Lilleshall Parish Council submitted a formal screening request regarding the need for a Strategic Environmental Assessment (SEA) and an Appropriate Assessment under the EU Habitats Regulations of the draft LNP. In January 2017 Screening Statements were produced in conjunction with Telford & Wrekin Council stating that neither an SEA nor an HRA ('Appropriate Assessment') was required. These original Screening Statements are included as part of the LNP submission and responses confirming the findings from Natural England, Environment Agency and Historic England are included in the Consultation Statement.

The original SEA and HRA were based upon and aligned with the Examination version of the Telford & Wrekin Local Plan. A revised Telford & Wrekin Local Plan containing a number of modifications following Examination was subsequently adopted on 11<sup>th</sup> January 2018.

The two principal modifications affecting the LNP were the removal of a large housing allocation within the neighbourhood plan area and the deletion of the Lilleshall Village Strategic Landscape Area (LVSLA). The removal of the housing allocation additionally supports and reinforces the conclusions of the original screening i.e. The removal of the allocation further reduces any potential environmental impact.

Although the adopted Telford & Wrekin Local Plan does not include the Lilleshall Village Strategic Landscape Area designation, the LNP believes that there is sufficient justification for its retention in the LNP. The continued inclusion of the LVSLA in the LNP means that this aspect (and conclusions) of the original screening remain the same. Revised versions of the SEA and HRA screening are provided as part of Regulation 15 of the Neighbourhood Planning (General) Regulations 2012.

Based on the screening statements and responses received, the Parish Council considers that the LNP does not require a Strategic Environmental Assessment under the SEA Directive and the Environmental Assessment of Plans and Programmes Regulations (2004) nor a Habitats Regulations Assessment under The Conservation of Habitats and Species Regulations 2010 (as amended). This is because there will be no significant environmental effects arising from its implementation and that it supplements national guidance whilst for HRA purposes none of the proposed policies within the LNP has potential to lead to a Likely Significant Effect on a European Site. Therefore, the LNP can be 'screened out' of the HRA process and an 'Appropriate Assessment' is not required. Amendments made to the LNP following Regulation 14 are not significant in relation to SEA and HRA so the Parish Council considers the findings of the screening statements to be unaffected.

In summary, the removal of the housing site allocation from both the new Telford & Wrekin Local Plan and the Lilleshall Neighbourhood Plan as well as the continued designation of the Lilleshall Village Strategic Landscape Area has served to decrease the potential environmental impact of the neighbourhood plan and maintain environmental protection.

Since the screening of the previous version of the plan established that the LNP did not require an SEA or HRA and the current regulation 15 version of the Lilleshall Neighbourhood Plan is unchanged apart from the deletion of one Local Green Space and the removal of a large housing site allocation

(which had the potential for greatest environmental impact), it is presumed that the conclusion of the original screening remains unchanged.
