2026/41	Chair's Items: • Karen Povey introduced as new Clerk & RFO. Employment commenced on 1st June 2026 following the resignation of former Clerk & RFO, Angela Vint • Government Restructuring of Councils Proposal: The Government wants more areas of England to have: ▪ A Strategic Authority (formerly known as a 'Combined Authority', led by a directly elected Mayor in many cases. ▪ Larger unitary councils that are considered financially sustainable. ▪ More decisions on transport, housing, economic development, and skills made locally rather than by Whitehall.	<u>Chair/ Clerk</u>

	What could happen to Shropshire? There are several possibilities, although no final decision has been made. • Option 1 – Shropshire remains a single unitary council • Shropshire Council could continue as one authority if Government considers it large and financially viable enough • It could then become part of a wider strategic authority with neighbouring councils for devolved powers • Option 2 - Shropshire joins with neighbouring authorities • Government could require Shropshire to work within a larger strategic area, potentially alongside authorities such as Herefordshire and/or Telford & Wrekin (although many different combinations have been discussed) • Local services such as planning, highways and waste could remain with Shropshire Council, while transport, investment and economic strategy sit with the new authority ▪ Option 3 - Reorganisation of councils • If Government decides existing councils are too small or financially weak, boundaries could change or, authorities could merge • This is one of the issues currently being explored nationally What might it mean for Parish Councils? For Parish Councils like Nash, day-to-day responsibilities are unlikely to change immediately. However there could be: • More emphasis on Parish and Town Councils delivering very local services • Greater opportunity to apply for community funding • Increased consultation on local priorities • Possible transfer of some assets or responsibilities from principal councils over time • More partnership working with neighbouring parishes
