Minutes of the Ordinary Meeting of the Parish Council held on Thursday 10th March 2022 at 7.30pm

(2021/22 – 154) Present were Cllr Martin Kirbitson (Chairman), Cllr Jim Wigginton and Cllr Simon Learoyd.

(2021/22 – 155) Also present were David Taylor, Clerk, Cllr Margret Atkinson and 3 members of the public.

(2021/22 – 156) Apologies were received from Cllr Smeeden and Cllr Parry.

(2021/22 – 157) There were no **Declarations of** Interest received and so no Dispensations were required.

(**2021/22 – 159**) It was **resolved** that the minutes of the meeting held on 13th January 2022, having been circulated for consideration beforehand were true and correct records. The Chairman signed them accordingly.

(2021/22 – 160) Cllr Margaret Atkinson **reported** on the following from North Yorkshire County Council:-

- 1. In July 2021 the Government announced that a new single council would be formed to deliver all services across North Yorkshire on the footprint of the current county council. This new council will replace the current county and the seven district and borough councils and it will be in place from 1 April, 2023. The Structural Changes Order approved by Parliament in March 2022 states that 90 new councillors will represent 89 divisions across the county.
- 2. On Thursday 5 May, North Yorkshire residents will be able to vote for the person they want to represent them at the county council elections.
- 3. Harrogate and Scarborough will be "Parished" in the formation of the new Unitary Authority.
- 4. It is anticipated that there will be an adjusted view of planning policy for rural areas after the formation of the new Unitary Authority.
- 5. More potholes will be repaired in the County this month as the Highways Department are barrowing a specialist machine for the purpose.

(2021/22 – 161) Cllr Margaret Atkinson **reported** on the following from Harrogate Borough Council:-

It is business as usual at Harrogate Borough Council but staff are leaving their positions in advance of the District Council being abolished by the formation of the Unitary Council in 2023.

Ripon Baths are now open but the leisure centre is closed due to a sink hole

Plans for a £17m leisure centre in Knaresborough - the town centre's biggest building project in decades - have been approved. Harrogate Borough Council passed its own plans for the new facility to be built over a play area at Fysche Field. The existing Knaresborough Pool will be demolished to make way for a larger car park and new play equipment.

New re-cycling wheely bins will be trailed by the Council in the near future.

(2021/22 - 162) The Clerk reported that:-

- a. After some 21hrs of work by the Clerk, the HSBC Safeguarding process was now concluded. A discussion ensued concerning moving banks. It was agreed that if this were to be considered further it would not be priority because it would be a time consuming process.
- b. Ripon Police had been invited to a future meeting and asked for the resumption of the reports that were forthcoming and valued until recently. Nothing had been head in response.
- c. The Clerk confirmed that there were elections this year & new Councillors for Grantley were required.
- d. The Lime tree on SVG had been trimmed.
- e. The revised "Terms and Conditions" for the use of Sawley Village Green are now published on the Parish Council website.
- f. There had been an approach by Grantley Hall Hotel who wished to work with the Parish Council in order to improve relations between the locality and the business. An invitation to attend a future meeting should be extended and Councillors were invited to draft a list of questions / problems to be discussed at the session.
- (2021/22 163) A Ripon Community Police Report was not received.
- (2021/22 164) The caretaker reports from DTMS were received and approved with no comment.
- (2021/22 165) The Clerk informed the Council of the terms of the YLCA Auditor Panel, and it was therefore resolved to appoint the Yorkshire Local Councils Associations Internal Audit Panel as its independent internal auditor for the 2021/2022 financial year.
- (2021/22 166) The Clerk was asked to investigate how to obtain "hit rates" for the website.
- (2021/22 167) It was noted that the rent paid by NYCC for the use of Picking Gill had been at the present level for over 10 years and was due to be reassessed. It was resolved that £750 per annum would be a reasonable rent to negotiate on. The Clerk should progress this.
- (2021/22 168) It was also reaffirmed that the rent for Picking Gill should support the maintenance of the area should it be necessary.
