# b. Questions from the public – None received

National Trust representative – Adam Curtis confirmed that they are still looking into policies regarding deer management. He confirmed that there are certain plants and flowers that deer do not like. He confirmed that there are 3 members of National Trust that can cull in woodland on National Trust land. All Game keepers have to have Licences to be able to shoot deer.

**c.** Personnel from Orsted and VolkerFitzpatrick introduced themselves to the parish. After giving a short presentation, they answered questions from residents and councillors on the following topics:

#### **Light pollution**:

Residents and OPC raised serious concerns about the excessive amount of light coming from the compound, as well as from how far it can be seen. Residents voiced their issues about light now filtering directly into their homes and had provided photos to the showing light pollution impacts in the nearby village of Corpusty, 3 miles away.

Greg Peck urged VFP to contact David Hook, the expert on rural light pollution for CPRE Norfolk, who has information about the correlation between excessive use of permanent security lighting on construction compounds and an increase in thefts. VolkerFitzpatrick said they were only recently aware that the lighting was causing an issue and have arranged for a 'qualified electrician' to come on Thursday 26th October, to try to rectify the positioning of the lights and determine whether they need all of them. A change to movement- sensitive downlighting, especially outside their permitted working hours of 7am - 7pm, was also discussed and VolkerFitzpatrick appeared to take this on board.

OPC and residents were asked to monitor and provide feedback on the situation. Orsted will contact the Chair with an update and the outcome of the work. The Chair will then contact residents with the update.

**Other issues** were also raised about the compound, including: the nuisance of car alarms, the need for changes to some signage, and questions about traffic. For full notes on this part of the meeting, please see attachment.

Adam Curtis – Countryside Manager for National Trust introduced himself. He confirmed how the National Trust look after and control the deer on their estates and tenanted farms. He was asked if a working party could be set up to look into a Deer Management plan. He confirmed he would look into this and report back. It was discussed about the deer on the roads from dusk. Mr Adam Curtis confirmed that the Deer are not able to be controlled at night.
