

MINUTES of a PLANNING COMMITTEE MEETING held on Wednesday, 15 January 2014 at The Almonry, High Street, Battle at 7.30pm

Present: Cllr R Jessop - Chairman
Cllrs D Furness, M Kiloh, M Howell and M Palmer.

1. **Apologies for Absence** – Cllrs R Bye, J Gyngell and S Pry.

2. **Disclosure of Interest** – None.

3. **Minutes of the previous meeting** held on 8 January 2014. Cllr Palmer proposed approval of the minutes, seconded by Cllr Furness. This was agreed and they were duly signed.

4. **Matters Arising from Previous Meetings**

Cllr Jessop reported that he had received no reply from Rother District Council regarding enforcement concerns.

5. **Correspondence & Communications**

The Committee noted:

- there was no update to the previous **enforcement cases** list;
- the latest **list of decisions** as attached;
- the usual temporary **road closure** for **St George's Day Procession on Sunday 27 May 2014**;
- a **letter of objection** from a neighbour to application **RR/2013/2567/P Adanac, Whatlington Road**, discussed at previous meeting;
- an email from **East Sussex County Council (ESCC)** detailing a proposal to supply **additional lights around the library building**. These will be positioned high to protect against tampering and will be either PIR or timer controlled. The Committee supported this scheme for both safety and anti-social reasons;
- a letter from **Rother District Council (RDC)** recording that they do not have a responsibility for the **lighting in the Market Square**. RDC have written to Jempson's stating that the area is the responsibility of the freeholder, Top Markets (Sussex) Ltd. Members highlighted concerns of safety, litter and antisocial behaviour and asked the Asst Clerk to write to Top Markets (Sussex) Ltd requesting immediate action to ensure safety and hygiene for our residents, visitors and businesses. A request to the PCSOs to patrol the area more frequently was also agreed.

6. **To Consider Planning Applications Received to Date** - None

7. **Matters for Information/Future Agenda Items**

Cllr Palmer reported concerns that **parking in Saxonwood Road** could cause obstruction to any emergency services vehicles. It was agreed that ESCC should be asked if this could be attached to the current proposals being consulted for North Trade Road and Caldbec Hill.
