025/1415 REPORTS

Cllr Wild reported on plans for a revised LJC area. It is proposed that the parish will fall under Shrewsbury Rural LJC area.

Cllr. Wild also outlined the Community Speed Watch scheme. This is a West Mercia Safer Roads Partnership initiative. It will give members of the public the chance to be trained to use handheld speed guns in monitoring speeds and to carry out the monitoring. Unfortunately, it

only applies to 30/40mph zones; the parish wanted to express an interest and Cllr. Pritchett asked if ANPR cameras can be used.

Cllr. Wild also reported that Ian Walsham is now the local highways contact at Shropshire Council. Cllr Nelson had made contact with Bob Thurston from National Trust (NT) and discovered they were voluntarily mowing the verges in the vicinity of the bus stops near Norton crossroads. Cllr Nelson had seen the end result and noted his appreciation of their goodwill in carrying out this work but he also raised the matter of the overgrown hedges adjacent to the footpath between Norton crossroads and the Horseshoes. These hedges are owned by NT and the adjacent farmland is tenanted by Chris Marsh. Mr Thurston agreed to contact Mr Marsh to ask if they could be cut back hard at the earliest opportunity.

This dialogue will continue and the situation will be monitored going forward.
