f) National Salary Award

The National Salary Award for employees of local councils has been agreed for 2025-26. The award is effective from 1st April 2025 and will result in the salary of the Clerk being increased from £14.13 per hour (scale point 11) to £14.59 per hour. A copy of the new scales is attached.

The Clerk is currently employed on a contract of 4 hours per week and the award would therefore cost the Council an extra £95.68 per annum gross.

In addition, there would be back pay owing from 1st April 2025 which amounts to £47.83 gross.

The Council is requested to approve the new salary scale and back pay with effect from 1st April 2025.
