68/2022 Report from Cllr Lezley Picton

Shropshire Council's proposed precept is +4.99% (which includes 2% for adult social care). SC is looking into charging Council Tax for second homes. The boundary review (electoral wards) currently under consultation may mean changes to the Tern Division. Withington may be moved to a newly created electoral ward.
