General, unallocated reserves are made up of the Henry Town legacy and cumulative underspends. No decisions have been specifically linked to these reserves as with the Quinn Donation, neither has spending of these reserves been recorded and monitored

2. Previous Decisions and Commitments Regarding Quinn Donation

6th **November 2017** - it was resolved to seek resident's suggestions to spend the Quinn donation

19th **March 2018** – reviewed all suggestions according to legality and feasibility and divided into Red – no go; Amber – unlikely; Green – explore further.

10th May 2019 – Speed Indicator devices added to the list to be explored

- **22 January 2019** Cllrs Collins and Brown tasked to open discussions with the Landlord of the Kings Head regarding purchase of freehold for village green. Point of Interest Stone added to the list of schemes
- **12 March 2019** regarding purchase of the village green report back from Cllrs Collins and Brown led to decision to await advice from the landlord of the Kings Head before proceeding further
- **8 November 2021** It was agreed that the council will explore options to purchase land which might potentially assist the project.

4. Current position on the purchase of the village green

The chairman has recommenced discussions with the Landlord at the Kings Head and will report progress to the meeting on 7th March 2022.

5. Advice on Minimum Reserve Holdings

NALC guidance suggests that an appropriate level of unallocated reserves would be six months, or 50%, of the annual budget –i.e. approaching £4K. During his annual review in May 2021, the internal auditor recommended that once the reserves fell to £20K councillors should be advised to maintain that level. This was not included in his annual report, but I suspect arose from his awareness that we were pursuing an expensive traffic calming scheme at the time with higher maintenance costs (e.g. the granite sets in the chicanes). We had also agreed to create a "Repairs Fund" which would also swell the reserves over time. A minimum level of reserves might derive from the NALC recommended £4K plus the repairs fund intended to build up towards £10K making £14K in total? This could be rounded to £15KThe council has now abandoned the repairs fund idea due to the lower cost of repairs and the size of the reserves. The council should review its "minimum level of reserves" in view of both the NALC guidance and the lower level of potential repairs costs for the speed reduction scheme. It is suggested that a minimum level of reserves should be set at £15K, but the Internal Auditor is asked to review this figure and advise the council on this suggested figure is appropriate.

6. Suggested Actions

I recommend the following:

- (i) The remaining Quinn Donation money £52899.38 is allocated for the potential purchase of the village green and held for a further 12 months and then reviewed
- (ii) Minimum reserves are set at £15K subject to any views from the Internal Auditor in his annual visit in May 2022. This should enable the council to cover any major unforeseen difficulties and the maintenance of the speed reduction scheme.
- (iii) This leaves £17,591.92 unallocated and available to spend and should be used for small projects as they arise such as the path in the churchyard, replacement of stiles with gates, SID and purchase of land on which to locate the village shop
- (iv) The Council should ask the Clerk to produce a "Reserves Policy" for approval at the next Parish Council Meeting. The attached example provides an indication of this requirement.
- (v) The council should conduct an annual review of its reserves to update its policy. This should take place at the same time as setting the revenue budget
