Traffic Calming Bearing in mind views from the public meeting held earlier in the evening it was decided to hold a further meeting with KCC Highways to discuss how best to revise the plans to respond to the comments received. This includes better information and explanations underpinning recommendations. It was agreed that this will also form part of the next discussion with KCC.
